QUESTION: 1) Controller and Meter Cabinets: The checklist requires a test report using a CMU tester. Will the CMU tester be provided by Miami Dade County, or is it the contractor's responsibility to acquire one?

RESPONSE: 1) The contractor is responsible for acquiring a conflict monitor unit (CMU) tester to perform and produce CMU test reports.

QUESTION: 2) Vehicular Signal Heads: The checklist specifies checking every signal light. Will a lift or bucket truck be required for this task?

RESPONSE: 2) The contractor is required to inspect and clean several overhead components including traffic signal heads, vehicle detection cameras, CCTVs, internally illuminated street name signs, etc. The contractor will require a lift or bucket truck to access these devices.

RESPONSE: 1) The contractor needs to inspect all pull boxes at the intersection and install any missing bolts to ensure they are securely fastened.
