Please refer to General Note, sheet No. B 1-3 Existing Bridge Demolition and Appendix H of the Special Provisions under Addendum No.2.

Please indicate if Sand Cement Rip Rap is needed on this project. If yes, please add a bid item/quantity where we can include the cost for this work.

QUESTION: 5) Pile Rebar Detail on B1-12 – Section A-A shows 6 - #10B bars at the top of pile in addition to the 6- #10 A bars that extend full length. No dimension is given for the #10B bars but states to see note 4. Note 4 only refers to splices. Are the #10B bars only shown in case the #10A bars need to be spliced? If they are in addition to #10A bars, please provide required length of #10B bars.

RESPONSE: 5) #10 B bars are shown in case they need to provide splices which must be mechanical splices.

QUESTION: 6) Note 10 on B1-11 states that compression load test(s) shall be performed at locations indicated in the plans. No test pile locations are noted on the foundation layout on B1-10, only 2 ea. demonstration piles. Please provide require number of test pile(s) and location(s) and confirm that bi-directional load tests would be acceptable.

RESPONSE: 6) Compression Load test needs to be performed on Demonstration pile's locations where are the proposed piles, as they are shown in the Foundation Layout Sheet B1-10; End Bent 1, Pile 5 and End Bent 2, Pile #3.
