QUESTION:1) Could you please clarify whether a **printed electronic Bid Bond with an e-seal** will be accepted, or if the County requires the original physical bond issued by the surety?

RESPONSE:1) Simultaneously with the delivery of the Bid to the County, on or before the bid due date, the Bidder must deliver to the County a bid security in the form of a Bid Bond on the form provided in the Bidding Documents or in Cash, in the form of a Certified Check, Cashier's Check or Irrevocable Letter of Credit made payable to the Department, for an amount equal to no less than five percent of the Total amount Bid.
Refer to Article 1.02 Bid Security of the Supplementary Instructions to Bidders in the Solicitation Documents.

QUESTION:2) I understand that the bid package must be submitted physically. However, I did not find any language in the bidding documents indicating whether the Bid Bond itself must be an original hard-copy bond or if a printed electronic Bid Bond is acceptable.

RESPONSE:2) Bid bonds must be delivered to the County on or before the bid using the county's standard format including in the Solicitation Documents in the original hard-copy or printed electronic.
Refer to Surety Bid Bond Form under Solicitation Forms in the Solicitation Documents.

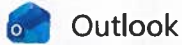
