- Q11. Specification 27 4100 Audio-Video Systems includes an equipment list. This list includes line items on page 11 of 12 calling for a Lectern and a VGA to HDMI Converter. These items are not specified. As the value of these items can significantly vary, we respectfully request that an allowance value be listed. We believe this is the fair way to address the matter until such time that the products can be specifically identified.
- A11. Lecturer/Podium: AVFI PD3004 BRL with CUB4 and a C900s included; VGA to HDMI converter: Kramer ADC-GM/HF
- Q12. Speaker quantities listed are "pairs" or single items? It lists Qty 73 for JBL & 14 for Tannoy speakers, but the description mentions "Pairs". So is it 73 single speakers or 73 pairs (146)
- A12. We encourage any integrator bidding a job to take a moment to open up the speaker layout plans and verify the number in the plans to the equipment list. The speaker model listed as pairs are only sold in pairs of two only not singles so it is 73 pairs of speakers totaling 146 for the JBC24CT and 28 for the Tannoy CVS8.
- **Q13.** Please provide MDPLS burglary alarm standards, as mentioned in bid set note 2.D, Sheet A000
- A13. Bidders are encouraged to look through the entire bid set package, including the technical specifications before bid. Refer to the appendices portion of Volume 2 Technical Specifications.

Clarification on finishes for the interior and interior signages:




