Miami-Dade County's Parks, Recreation Open Spaces Department ("PROS") is requesting an Invitation to Bid (ITB) for vendors to provide Wide Area Network (WAN) services for guests. This system will not interact with the Miami-Dade County network nor provide access to any internal systems or applications. The scope of work for the contract is inclusive of the services listed below:

- a. On-site Survey: Vendor will perform an on-site survey to assess the customer's needs and evaluate the feasibility of the proposed solution. This will include identifying optimal locations for access points and assessing any potential challenges.
- b. Network Design: Based on the results of the on-site survey, Vendor will design a network that meets the customer's needs. This will include selecting appropriate equipment and determining the optimal placement of D-Marks and entry points into Park facilities.
