- A8. A separate deductive alternate listing will not be required. The dampers, damper motors, and damper controllers remain as part of the base bid.
- Q9. Fire Protection Scope Note 5, Drawings A-302 through A-307: The fire protection drawings FP-101 through FP-204 do not show any fire protection work in the vast majority of this space. If there is any work required by the referenced Note 5 above, please clearly detail.
- A9. Note 5 on Drawings A-302 through A-307 is applicable only to areas affected or modified by the Work depicted on drawings FP-101 through FP-204 as well as areas altered in the Scope of Work as defined in the Contract Documents.
- Q10. Paint Scope, Notes 10 and 11, Drawings A-302 through A-307: Is the intent to paint everything above the ceiling and that which is exposed? This could be a significant expense. Please clarify the exact scope and location of items to be painted.
- A10. Notes 10 and 11 refer to areas where painting is required by Code. In addition, Notes 10 and 11 refer to any uncovered existing or new exposed structural steel that is neither painted nor galvanized (essentially unprotected steel). Elements other than those described above in the interior of the exposed ceiling in the mechanical rooms or the UPS room, do not require painting.

Description of Project/Bid:

The LightSpeed building is located at 11500 NW 25th Street, Sweetwater, Florida, 33174. The Lightspeed facility was exhibiting multiple roof leaks. Some of the leaks were due to the roof itself; others were due to the leaking rooftop packaged air conditioning equipment. It was established that the rooftop units' weather resistance did not last as long as the roofing material alongside them. It was also determined that the ability of the rooftop units to survive hurricaneforce winds was far less than that of the building. Consequently, a design concept paradigm shift was introduced to maximize the sustainability of the building. This meant abandoning the rooftop unit air conditioning concept and introducing an indoor chiller plant and indoor air handling units along with a new robust roof as described in the scope of work below.

Sec. 2-8.2.6.1. - Buy American Iron and Steel Products Procurement Program.

- (1) Policy and Scope. This section shall be known as the "Buy American Iron and Steel Products Procurement Program" and is intended to set forth requirements to use iron and steel products produced in the United States for construction contracts that are subject to approval or ratification by the Board of County Commissioners.
- (2) Definitions. For purposes of this section:

County Mayor wherever used in this section shall mean the County Mayor and his or her designee.

*Iron and steel products* shall mean products made primarily of iron or steel, including, but not limited to, lined or unlined pipes and fittings, bars and rods, wire, wire ropes and link chains, forgings, manhole covers and other castings, hydrants, tanks, flanges, pipe clamps and restraints, valves, structural steel, materials made primarily of iron and steel within precast concrete, and other construction materials made primarily of iron or steel.

Manufacturing process shall mean the application of a process to alter the form or function of materials or elements of a product in a manner that adds value and transforms the materials or elements into a new finished product, but does not include the process of merely placing the materials or elements on a construction site or assembling finished materials or elements into a product.

Produced in the United States shall mean, with respect to iron and steel products, a product for which all manufacturing processes, from initial melting through application of coatings, occur in the United States, other than metallurgical processes to refine steel additives.

*Project* shall mean a construction contract between Miami-Dade County and a private contractor for public improvements that is subject to the approval or ratification by the Board of County Commissioners.

- (3) Iron and Steel Products Procurement and Contracting Requirement. All solicitations and contracts for projects in which iron and steel products shall be used shall include terms and specifications requiring that any iron and steel products produced through a manufacturing process and used in the project be produced in the United States.
- (4) Exceptions. The requirement set forth in subsection 3 shall not apply, if:
  - a. Iron and steel products are not produced in the United States in sufficient and reasonably available quantities or of a satisfactory quality; or
  - b. Inclusion of iron and steel products produced in the United States will increase the cost of the project by more than 20 percent; or
  - c. Upon a written recommendation of the County Mayor approved by a majority vote of the Board members present, compliance with the procurement and contracting requirements in subsection (3) are not consistent with the best interests of the public.
- (5) Federal law, Florida law and International Agreements. This section shall be applied in a manner consistent with existing federal law, State of Florida law and any obligations applicable to Miami-Dade County under international agreements.
