This Addendum is issued to clarify and/or modify the previously issued Invitation to Bid, and is hereby made part of the Contract Documents. All requirements of the Invitation to Bid not modified herein shall remain in full force and effect as originally set forth. Bidders are required to acknowledge receipt of any and all addenda as instructed in the bid proposal form provided to that effect.

MODIFICATION(S)

1. Revise Scope of Work in Bid Documents' (a) RPQ Invitation to Bid, (b) Price Proposal Form Attachment 5-A, and, (c) General Contract Conditions (Section No. 1.) by adding the language (underlined, italics) below:

Scope of Work

j. Landscaping related to trees, shrubs, and ground cover/sod is excluded from the scope of work except as described herein. The landscaping that has been removed from the scope of work is the procurement and planting of trees, shrubs and ground cover/sod on the landscaping schedule on Sheet L.S.-2.2 as they will be procured and planted through a separate program in partnership with Miami-Dade County Parks, Recreations and Open Spaces (PROS). The Kapok tree and silk floss tree remain part of the scope of work for the Contract, as they will not to be procured and planted separately. Throughout the project, the Contractor will coordinate with the PROS vendor to coordinate the landscaping work, and provide PROS with a 30 day notice of clearance to procure and plant the trees and shrubs required. The Contractor will be responsible for ensuring PROS vendor has access to the site prior to and during landscaping. The Contractor will include fees related to coordination of the vendor selected by the County as part of their base bid. All other landscaping work such as hardscaping, furniture, irrigation, lighting, and tree mitigation for relocation of the existing Live Oaks and shrub hedges will be the responsibility of the Contractor.

Restrictions/Requirements

- a) Purchase, installation and testing of all equipment necessary for the successful implementation of the specified audio/visual equipment, <u>on Sheets AV-01 to AV-08</u>, is <u>remain</u> excluded from the scope of work, <u>as procurement and installation of the work is being completed through a separate County Contract. The Contractor will include fees related to coordination of the installation of the equipment by the County vendor as part of their base bid.</u>
- b) Landscaping related to trees, shrubs, and ground cover/sod is excluded from the scope of work <u>(refer to Item j above).</u>

2. Revise Bid Submittal's Experience Requirement in Bid Documents' (a) RPQ Invitation to Bid and (b) General Contract Conditions (Section No. 7. Bid Submittal and Opening) by revising the language below:

THE COUNTY REQUIRES, after Bid Opening and within three (3) business days of County's written request, Bidder's references for projects that are representative of similar scope, of equal or greater value, and that demonstrate a MINIMUM REQUIRED of: five (5) to ten (10) years EXPERIENCE and two (2) similar COMPLETED PROJECTS. In accordance with Resolution R-1122-21, the experience of the Bidder's key personnel will be considered in assessing whether the Bidder complies with this solicitation's minimum experience or completed project requirement. References must include the following information: 1) a description of scope of work performed; 2) project address; 3) name and title of Bidder's key personnel assigned to that project; and, 4) client contact information: name, address, phone number, email address, project cost, and project start and completion dates. The Prime Contractor shall be required to provide a list of Example Projects that demonstrate each Firm's key individuals' ability and experience to successfully plan and complete the project.
