Scope of Work:	(Contractor must obtain and submit all permits prior to performing any work). Prospective bidder shall visit and carefully examine the site to familiarize themselves with all existing conditions prior to bid. Bidder shall carefully review approved plans and quantify devices to be installed. Bidder shall be responsible for measuring and calculating amount of work. Bid price is to include the removal and proper disposal of all work- related debris. The project consists of, and is not limited to, furnishing all materials, labor, services, supervision, tools, equipment, including all associated permits, and all other items necessary for the successful completion of the project, which shall expand an evidence vault capacity by building a new vault, reorganizing existing furniture (workstations) to accommodate the vault addition, and adding new furniture (workstations) in an existing space. The work will require project phasing, as described below. These renovations will take place on the 9th floor of Richard E Gerstein Justice Center, located at 1351 NW 12th Street, Miami, FL 33125, as described in summary below and identified in the construction documents. The scope entails the following: EVIDENCE VAULT EXPANSION • The vault expansion consists of creating a new space approximately 970 SQ.FT. consecutive with the existing Vault #2 (N-945). The expansion for the new evidence vault includes: - o New partitions, new finish floor and baseboard, and a new opening, as well as wall finishing and painting. - o Demolition of existing and installation of new 2'x4' acoustical ceiling tiles as indicated on plans. - o The new vault partitions must include barrier (security) mesh behind the drywall attached to the studs (DEA evidence room type). The new space (referred to as Vault #3) will be accessed from the existing Vault #2. A new access control point must be added to regulate and register the access to the new room, between both vaults. The prospective bidder shall include in his/her bid, provisions for all conduit and infrastructure required. Installation by others. • Fire Protection scope shall be to relocate and replace existing sprinkler heads to accommodate new vault as indicated on plans. • HVAC scope includes new distribution system, in specified areas, connected to existing, including new VAV boxes, as per plans. For the new vault, all ductwork penetrations through new partition shall have security barrier, as indicated on plans. New recirculation air purifiers to be installed inside new vault, as indicated on plans. • Electrical scope shall support all mechanically installed equipment (VAV's, etc.) as required and include new light fixtures to be installed and fed from existing circuit. • Low Voltage/Security includes the installation of cameras provided by owner and relocation of existing low voltage devices as depicted on plans. The prospective bidder shall include in his/her bid, provisions for all conduit and infrastructure required. Installation by others. PHASE I - NEW OFFICE FURNITURE (WORKSTATIONS) • Relocated open office space/ workstations area: Approximately 1,100 SQ.FT. Removal of file shelves from File Area (N-904) and installation of new office furniture (workstations). Designated area shall be prepared to accommodate new office workstations, including new power and						

lighting as shown on plans. The purchase of furniture shall not be included in the scope of work of this contract. The prospective bidder shall include in his/her bid, provisions for all conduit and infrastructure required. Bidder is responsible for coordination of installation. Installation by others.

- o Proposed new 14 office workstations, private office along with a copy/printer area and new cabinet to be included in File area (N-904) after existing file shelves have been removed. Layout, configuration and specifications as indicated on plans.
- o Relocate existing 2'x4' acoustical ceiling tiles as needed to accommodate new lighting layout.
- o New 2'x4' acoustical ceiling tiles where some light fixtures have been removed.
- o Removal of existing light fixtures and installing new LED fixtures. New lighting layout as per electrical plans.
- o Provisions of power to the new furniture from existing electrical Panel '9LC,' located on the 9th FL.
- o Low voltage/data systems as indicated on plans' new layouts. The prospective bidder shall include in his/her bid, provisions for all conduit and infrastructure required. Installation by others.

PHASE II - EXISTING OFFICE FURNITURE (WORKSTATIONS) RECONFIGURATION

- Once office personnel have been relocated to completed Phase I, the new evidence Vault #3 will be built along with remaining open office area, as shown on plans. New Vault #3 area: 970 SQ.FT.
- o The 14 workstations in open office area (N-923) adjacent to existing Vault #2 where new Vault #3 is proposed, will be removed and the remaining 8 workstations will be relocated within the same space, against the new vault #3 partition as indicated on plans. The renovation of the existing open office area where relocation of office furniture (workstations) is proposed also includes the following:
 - HVAC scope includes new distribution system, in specified areas to be connected to existing including new VAV boxes as per plans.
 - Electrical scope shall support all mechanically installed equipment (VAV's, etc.) as required, removal of existing light fixtures and installation of new LED fixtures fed from same lighting circuits currently used as well as power and low voltage/data outlets to be installed and/or relocated as needed to accommodate new layout.

Included in the Bid Documents are Asbestos Survey Reports that were performed for the entire REG Justice Center facility, inclusive of the 9th FL. The reports indicate negative results of the presence of materials in the specified areas of work and therefore abatement services are not required for pre-renovation. The project dry-run submittal has been approved by Miami-Dade County (MDC) Building Department. The process number with MDC is C2025128954. The contractor shall be responsible for verifying all fees, permits and obtaining all required permits/sub-permits for the project.

The estimated construction cost is \$310,665.70. This estimate includes \$13,377.95 estimated permit processing fees. The Bid shall consist of the Base Bid amount (Lump Sum) inclusive of all permit fees, excluding Contingency. NOTE: There are no Dedicated Allowances on this Project. A 10% Contingency will be added to the Base Bid at Project Award.

At the close of the project, Contractor shall submit all documentation, warranty, equipment specifications, etc.

Comments:	Pursuant to Section 2-8.10 of the Code of Miami-Dade County, this Contract is subject to a user access fee under the County's User Access Program (UAP) in the amount of two percent (2%). All construction services provided under this contract are subject to the 2% UAP. This fee applies to all Contract usage whether by County Departments or by any other governmental, quasi-governmental or not-for-profit entity. From every payment made to the Contractor under this contract (including the payment of retainage), the County will deduct the two percent (2%) UAP fee provided in the ordinance and the Contractor will accept such reduced amount as full compensation for any and all deliverables under the contract. The County shall retain the 2% UAP for use by the County to help defray the cost of its procurement program. Contractor participation in this pay request reduction portion of the UAP is mandatory. Provided, however, UAP shall not be applicable for total contract values, inclusive of contingency and allowance accounts, of less than five hundred thousand dollars (\$500,000.00). Pre-Bid Meeting and Site Visit: A MANDATORY PRE-BID MEETING AND SITE VISIT ARE SCHEDULED. Bidders who have not submitted a Confidentiality Affidavit will be requested to leave the Meeting and Site Visit. Bidders arriving after 10:10 AM WILL NOT be allowed into MEETING OR SITE VISIT. Examination of Bid Documents: Before submitting a bid, the bidder shall examine the Bid Documents including Plans/Specs, which must be obtained from People and Internal Operations Department (PIOD) Kristina Hagberg after submitting a completed, notarized Confidentiality Affidavit. Bid Documents consist of the RPQ information from CIIS, Attachment 5A (Bid Form), forms, Standard Construction General Contract Conditions, PIOD Special Provisions, as well as approved plans/technical specifications. All bidders shall become thoroughly familiar with all terms of this RPQ prior to the Pre-Bid meeting. Failure to do so will in no way relieve the Awarded Bidder from completing the required work for the bid price. Requests for Information (RFIs): All requests for information (RFIs) shall comply with the Cone of Silence, Administrative Order 3-27 and shall be emailed to kristina.hagberg@miamidade.gov with a copy to Aundria.Blatch@miamidade.gov and clerkbcc@miamidade.gov. The deadline to receive RFIs from bidders is no later than 2 PM on Tuesday, October 14, 2025. Responses cannot be guaranteed for RFIs submitted past the established deadline. Procedural questions may be entertained by phone or during the Pre-Bid Meeting. Bid Submittal: PIOD's MCC Bid Submittal procedure has been modified to ONLY ALLOW ELECTRONIC BID SUBMITTAL. Bidder will visit https://constructionbids.miamidade.gov and click on the "External Log In" link. Bidder will then select this RPQ No. from the drop-down list and will then have the ability to upload a Bid electronically. Bidder that has not previously created a miamidade.gov portal account will be prompted to do so prior to submitting a Bid. Bidder must combine ALL Bid documents into a single PDF file, with a 25 MB file size limit, for upload. Bidder will receive a				

confirmation email upon successful Bid submittal/upload.

Bidder must allow enough time in advance of the Bid Submittal Deadline to complete any necessary steps. The responsibility for submitting a Bid on or before the stated time and date is solely and strictly the responsibility of the Bidder. The County will in no way be responsible for delays caused by technical difficulty or caused by any other occurrence. All expenses involved with the preparation and submission of Bids to the County, or any work performed in connection therewith, shall be borne by the Bidder. No part of any Bid can be submitted via hardcopy, email, or fax, unless otherwise directed by the Solicitation documents. All references to "Sealed Envelopes" or "Sealed Bid" in the Invitation to Bid or Bid Documents shall mean an "electronic bid."

The Electronic Bid shall include the following documents:

Forms for #1-5 are provided in the Bid Documents.

Discrimination Lawsuits: In accordance with Miami-Dade County Resolution No. R-828-19, bidders are required to disclose discrimination lawsuits, including allegations of discrimination and dispositions of such lawsuits for a 10-year period through the date of the solicitation. Bidder must include its disclosure in its Electronic Bid.

Non-Collusion Affidavit

After Bid Opening and within three (3) business days of County's written request, the lowest, responsive bidder shall provide an executed Non-Collusion Affidavit if the total bid including contingency and, if applicable, dedicated allowance exceeds \$250,000.

Required Experience/Qualifications: The lowest, responsive bidder is required, after Bid Opening and within three (3) business days of County's written request, to provide the Bidder's references for projects that are representative of the general scope of work which is currently being advertised, of equal or greater value, and that demonstrate a minimum of five (5) years of experience and/or completed a minimum of three (3) similar projects. In accordance with Resolution R-1122-21, the experience of the Bidder's key personnel or Bidder's proposed subcontractor will be considered in assessing whether the Bidder complies with this solicitation's minimum experience or completed project requirement. References must include the following information: 1) a description of scope of work performed; 2) project address; 3) name and title of Bidder's key personnel assigned to that project; and, 4) client contact information: name, address, phone number, email address, project cost, and project start and completion dates.

Resource Allocation Plan (RAP): The Recommendation for Award will require Awarded Bidder to submit within 10 business days a preliminary RAP that must be approved by County prior to Work Start. The RAP should be in a spreadsheet at a minimum, but preferably included as part of the construction schedule prior to Work Start. The Awarded Bidder must identify the following in its RAP at a minimum:

- a. Trade (GC, Mechanical, Electrical, Plumbing, civil, shell, etc)
- b. Title (superintendent, laborer, mason, master electrician, etc)
- c. Start date
- d. End date
- e. Percentage allocated recommended. (For example, based on start and end dates a laborer is working 45 days, his resource allocation is 90%, then we should be able to account for 39 ½ days of labor.)
- f. Hours for each labor category

- Contractor shall indemnify and hold harmless the County and its officers, employees, agents and instrumentalities from any and all liability, losses or damages, including attorneys' fees and costs of defense, which the County or its officers, employees, agents or instrumentalities may incur as a result of claims, demands, suits, causes of actions or proceedings of any kind or nature arising out of, relating to or resulting from the performance of this Agreement by the Contractor or its employees, agents, servants, partners principals or subcontractors. Contractor shall pay all claims and losses in connection therewith and shall investigate and defend all claims, suits or actions of any kind or nature in the name of the County, where applicable, including appellate proceedings, and shall pay all costs, judgments, and attorney's fees which may issue thereon. Contractor expressly understands and agrees that any insurance protection required by this Agreement or otherwise provided by the Contractor shall in no way limit the responsibility to indemnify, keep and save harmless and defend the County or its officers, employees, agents and instrumentalities as herein provided.

The Contractor shall furnish to **People and Internal Operations Department, 111 NW 1st Street , Suite 2420, Miami FL 33128**, Certificate(s) of Insurance which indicate that insurance coverage has been obtained which meets the requirements as outlined below:

- A.** Worker's Compensation Insurance for all employees of the Contractor as required by Florida Statute 440.
 - a. If applicable should include coverage required under the U.S. Longshoremen and Harbor Workers' Act (USL&H) and/or Jones Act for any activities on or about navigable water.
- B.** Commercial General Liability in an amount not less than \$300,000 per occurrence, and \$600,000 in the aggregate. Miami-Dade County must be shown as an additional insured with respect to this coverage.
- C.** Automobile Liability Insurance covering all owned, non-owned and hired vehicles used in connection with the work, in an amount not less than \$300,000 combined single limit per occurrence for bodily injury and property damage.

*Under no circumstances are Contractors permitted on the Aviation Department, Aircraft Operating Airside (A.O.A) at Miami International Airport without increasing automobile coverage to \$5 million. Only vehicles owned or leased by a company will be authorized. \$1 million limit applies at all other airports.

VERIFICATION OF EMPLOYMENT ELIGIBILITY (E-VERIFY):

By entering the Contract, the Awarded Bidder becomes obligated to comply with the provisions of Section 448.095, Florida Statute, titled "Verification of Employment Eligibility." This includes but is not limited to utilization of the U.S. Department of Homeland Security's E-Verify System to verify the employment eligibility of all newly hired employees by the Awarded Bidder effective, January 1, 2021, and requiring all Subcontractors to provide an affidavit attesting that the Subcontractor does not employ, contract with, or subcontract with, an unauthorized alien. Failure to comply may lead to termination of this Awarded Bidder, or if a Subcontractor knowingly violates the statute, the subcontract must be terminated immediately. Any challenge to termination under this provision must be filed in the Circuit Court no later than twenty (20) calendar days after the date of termination. If this Contract is terminated for a violation of the statute by the Awarded Bidder, the Awarded Bidder may not be awarded a public contract for a period of one year after the date of termination, and the Awarded Bidder may be liable for any additional costs incurred by the County resulting from the termination of the Contract. Public and private employers must enroll in the E-Verify System (<http://www.uscis.gov/e-verify>) and retain the I-9 Forms for inspection.
