CHANGES TO THE INVITATION TO BID:

1. Delete Estimate value of \$198,996.00 and replace it with \$204,621.00.
2. As to the Scope of Work, Add the following work: Contractor to furnish, deliver and install 25 linear feet of painted galvanized rail 42 inches high.

CHANGES TO THE BID FORM:

3. Delete Bid Form on Solicitation Documents published on 9/21/2023 and replace it with attached Revised Bid Form for Addendum No. 1. Changes to the Bid Form are as follows:

Pay Item No.4, 25 Linear Ft of painted Galvanized Rail, 42" high (F&I), (LS) has been added.

CHANGES TO THE SPECIAL PROVISIONS:

4. Add the following Article 2.04, Galvanized Rail:
  - 2.03 GALVANIZED RAIL
    - A. General: Work includes furnish and install supervision, labor, materials, transportation, and equipment for a Painted Galvanized rail with the following specifications:
      1. 25 linear feet of powder coat, Galvanized rail 42 Inches high with a middle rail, with an outside diameter not less than 3.5 inches. Wall thickness should not be less than 0.25" Mid Rail high should be at 21" high.
      2. Rail to be installed on the roof as a fall protection system while performing maintenance on the Air Conditioning (A.C) unit. Rail Installation must comply with all the requirements of the Miami Dade County Regulatory and Economic Resources (RER) Department and any other local jurisdiction and meet the requirements of Building and Zoning codes.
    - B. Basis of Payment.
      1. All material, labor, material, transportation, permits and equipment are to be paid under pay item No. 4: 25 Linear Ft of painted Galvanized Rail, 42" high (F&I), (LS)
