METHOD OF AWARD TO PRE-QUALIFIED BIDDERS WHO WILL BE INVITED TO PARTICIPATE IN SPOT MARKET PURCHASES

(Additional information will be accepted during the evaluation) Award of this contract will be made to all responsive, responsible vendors who meet the minimum qualifications set forth in this solicitation. Those qualifications are as follows:

- a.) Provide evidence that firm is currently supplying at least one (1) large commercial or government account with similar goods and services as requested in this bid solicitation.
- b.) The County will require the bidder to show evidence that they have been designated as an authorized representative of a manufacturer, supplier and/or distributor. By letter from manufacturer, supplier and/or distributor:
- c.) Provide dedicated telephone and/or email address, separate facsimile lines to expedite quotes.

It is contingent upon all bidders to provide the necessary paperwork to substantiate the qualifications outlined above. This information must be provided along with the Bid Proposal Form at the stipulated Opening Date to be considered for prequalification status. Additional information will be accepted during the evaluation period.

QUOTE PROCEDURES:

These vendors shall then be deemed to be pre-qualified to participate in subsequent spot market quotations as required by the County on a periodic basis. When such spot market quotations are initiated, all vendors will be notified to provide prices based on identified items within the contract period that are fixed and firm.

ADDITIONAL MANUFACTURERS MAY BE ADDED

Although this solicitation and resultant contract identifies specific manufacturers to be purchased, it is hereby understood and agreed that additional brands may be added to this contract at the option of the County. Award of these additional manufacturer(s) shall be confirmed through the issuance of an addendum to the award sheet. These items shall become an integral part of the contract. The incumbent vendor(s) has/have no exclusive right to provide these additional manufacturer(s). The County may determine to obtain similarly structured pricing inputs from other vendors in response to situations where incumbent vendors do not provide for fair and reasonable pricing or for other reasons at the County's sole discretion.

PURCHASE OF OTHER ITEMS NOT LISTED WITHIN THIS SOLICITATION BASED ON PRICE QUOTES

While the County has listed all major items within this solicitation which are utilized by County departments in conjunction with their operations, there may be similar items that must be purchased by the County during the
