Title: Prequalification Manufacturer's Dealer (OEM) Parts & Repair Services

1: AWARD DESCRIPTION

Contract established to prequalify vendors to purchase Manufacturer Certified Dealer Original Equipment Manufacturer (OEM) parts and repair services. Contract covers passenger cars, station wagons, vans, pickup trucks, utility vehicles, suburban, walk-in-step vans and motorcycles.

2: METHOD OF AWARD DESCRIPTION – Prequalification of Vendors

In accordance with Section 2, paragraph 2.6, award (prequalification) is made to responsive, responsible bidders who meet the minimum qualifications set forth in the solicitation:

Additional bidders (Vendors) who meet the stated requirements can be added during the term of the contract.

3: MEASURES AND PREFERENCES

The following were applicable to competition conducted under this Invitation to Bid (ITB) solicitation:

Small Business Enterprise (SBE) Bid Preference: Application of the SBE or Micro/SBE preference shall be applied in accordance with Section 2-8.1.1.1.1 of the County Code covering this program.

Local Certified Service – Disabled Veteran Enterprise (VBE) preference shall be applied in accordance with Section 2-8.5.1 of the Miami-Dade County Code. A VBE who is also an SBE shall not receive the veteran's preference and shall be limited to any applicable SBE preferences. Vendor must affirm written compliance with the certification requirements of Section 295.187 of the Florida Statute to be submitted with a copy of the actual certification along with the bid or quote during competition.

Local preference for Local business and Locally Headquartered Business shall be applied in accordance with Section 2-8.5 of the County Code and the reciprocity agreement between Miami-Dade County and Broward County.

4a: AWARDED ITEMS

Items purchased under this contract will be on the basis of pricing submitted in accordance with Section 2, Paragraphs 2.6 Method of Award, Items B, E & F summarized below. (Refer to Contract Pricing tables).

B) Dealer's Warranty Repair Labor Rate Reimbursement Agreement

Hourly labor rates shall be based on prequalified Vendor having an agreement with the original equipment manufacturer (OEM) and shall be provided at no less than 15% Fleet Discount from current OEM agreement.

E) Supply of OEM Parts

Vendor shall supply and deliver parts to the County at no more than the direct Dealer Manufacturer to Dealer cost (bare and unloaded) + 25%.

F) Cost Verification Documents

Upon request by the County prequalified vendors must be willing to supply part cost books, tapes, microfiche, CD-Rom's or other documents to verify costs being billed for all parts and labor services.
