I. Purchasing Instructions:

A. Award Description

This contract is for the purchase of Rubber Stamps and Marking Products. Stamps and Marking Products are defined as tools used to imprint or impress an official mark, design, or seal that indicates ownership, approval, or completion. Marking Products are inclusive of the following: Pre-Inked Stamps, Self-Inking Stamps, Daters, Self-Inking Daters, Alphanumeric Band Stamps, Traditional Wooden or Plastic Stamps, Signature Stamps, Artwork/Logo Stamps, Inks, Stamp Pads, Seals and Embossers.

Quotation Directives

1. Prequalified vendors will be invited to participate in spot market purchases as required by the County for specific items or service. When spot market purchases are initiated, pre-qualified vendors shall be invited to offer a fixed price for a specific individual purchase/work order, or a specific purchasing period.
2. ALL quotations issued under this pre-qualification contract must utilize the current and active “terms and conditions” in place that includes the latest legislative changes. Please refer the Procurement Management link (<http://www.miamidade.gov/procurement/itb-terms-conditions.asp>) to retrieve that latest version of the current T&Cs.
3. All quotations issued must be provided to the Small Business Development Division (SBD) of the Internal Services Department for placement on the Cone of Silence Report upon advertisement. Once an award recommendation is made, SBD must be notified in order to remove the competition from the report.
