- I. **Re: Section 2, paragraph 2.21** - USER ACCESS PROGRAM APPLIES to this contract except for federal funds

- II. **County User Access Program (UAP) - User Access Fee**
Pursuant to Miami-Dade County Budget Ordinance No. 03-192, this quote and any resulting order is subject to a user access fee under the County User Access Program (UAP) in the amount of two percent (2%). The vendor providing goods or services under this contract shall invoice the contract price and shall accept as payment thereof the contract price less the 2% UAP as full and complete payment for the goods and/or services specified on the invoice. The County shall retain the 2% UAP for use by the County to help defray the cost of the procurement department. Vendor participation in the UAP is mandatory.

- III. **Re: Section 2, paragraph 2.6:**
Vendors listed on the award sheet have been pre-qualified to participate in spot market purchases as required by the County on either an as-needed or on a periodic basis. When such spot market purchases are initiated, the pre-qualified vendors shall be invited to offer a fixed price for a specific individual purchase, or a specific purchasing period. The vendor then offering the lowest fixed price shall be awarded for the specific period or specific purchase. The award to one vendor for a specific period or individual action does not preclude the remaining pre-qualified vendors from submitting spot market offers for other specific purchases.

- IV. In the best interest of the County, for items either delivered by the vendor or picked-up from the vendor by authorized County personnel, the availability of the material, geographic location, and/or delivery time may be utilized as deciding factors for the basis of an award to a bidder when it is determined by a County department that a project is time sensitive to meet pre-established deadlines or it is an emergency situation.

- V. Spot Market pricing procedures may be initiated by either the using County department or by the Internal Services Department. Quotations should include the following:
 - Re: Section 2, paragraph 2.17 - Delivery requirements
 - Re: Section 2, paragraph 2.7 - Term the prices need to be fixed and firm
Re: Section 2, paragraph 2.6 - Spot market quotes can be for a fixed price or for a specific period (depending on market condition a department can issue a quote for a term of as many months as the department believes is in the best interest of the County).
 - Re: Section 1, paragraph 1.10 - A space for the vendor to indicate if a local vendor.
 - Re: Section 2, paragraph 2.2 - A space for the vendor to indicate if certified Small Business Enterprise
 - A method of award – examples: by item, by group, etc.
 - Re: Section 2, paragraph 2.16 – Shipping Terms for all drainage materials purchased under this contract is FOB destination.

Note: The SBE preference shall be applied at the time of competition.
