I. Purchasing Instructions

A. Award Description

Groups 1, 2, 4A and 4B were awarded to the lowest priced responsible and responsible bidders in the aggregate, per group. Awarded bidders for Groups 3 and 4C have been pre-qualified to participate in spot market purchases for the purchase of emergency repairs.

B. Quotation Directives

- 1) For Group 3 – Emergency Repairs, Group 4C – Miami-Dade Housing Agency Emergency Repairs, and for the Purchase of Other Items (Re: ITB Paragraphs 2.6 and 2.36)

When a spot market purchase is initiated, the pre-qualified bidders shall be invited to offer a fixed price for a specific individual purchase, or a specific purchasing period. The bidder then offering the lowest fixed price shall be awarded for the specific period or specific purchase. Spot market pricing procedures may be initiated by a using County department or by the Procurement Management Division of ISD. Spot market quotations will include specifications, quantities, due date and any delivery requirements. In general, written spot market quotes will be gathered from all pre-qualified bidders.

- 2) Cone of Silence

Pursuant to Section 2-11.1(t) of the County Code, all ITQ's are subject to the Cone of Silence.

- 3) Bid and Local Preferences (Re: ITB Paragraphs 1.10 and 2.2)

Bid Preference and Local Preference will be considered when evaluating the offered prices, as permitted by funding sources. The Bid Preference shall be applied to the offers received from certified Micro/SBE bidders. The resulting Micro/SBE bidders' evaluation prices shall then be compared to the other offers to determine if Best and Final Offers (BAFO's) need be requested in accordance with the Local Preference legislation.

C. Emergency Purchases (Re: ITB Paragraph 2.6)

In the best interest of the County, for items either delivered by the vendor or picked-up from the vendors by authorized County personnel, the availability of the material, geographic location and/or delivery time may be utilized as deciding factors for the basis of an award to a vendor when it is determined by the County department that a project is time sensitive to meet pre-established deadlines or it is an emergency situation.
