This includes a base contract amount of fifty-seven thousand dollars and zero cents (\$57,000.00), a contingency amount of five thousand seven hundred dollars and zero cents (\$5,700.00), and dedicated allowances totaling one thousand two hundred dollars and zero cents (\$1,200.00).
