All pricing outlined is effective upon execution by the County:

ALL TERMS, COVENANTS, AND CONDITIONS OF THE ORIGINAL CONTRACT SHALL REMAIN IN FULL FORCE AND EFFECT, EXCEPT TO THE EXTENT HEREIN AMENDED.




