PURPOSE: The purpose of this contract is to purchase Locksmith Services in conjunction with the County's needs.

I. Purchasing Instructions:

Award Description

Award of this contract will be given to the lowest priced, responsive, responsible Bidder on a group-by-group basis who met the qualifying criteria.

Group I-Non-Federally Funded Departments

Group II-Federally Funded Departments

Prices:

Prices shall be fixed with adjustments allowed that are mutually agreed upon by the Bidder and the County. Initial contract prices shall prevail for a one (1) year period from the contract's initial effective date. The County may consider an adjustment after the first year, to be effective each anniversary date. Pricing adjustment shall not be in excess of the increase reflected on the latest Consumer Price Index for **Locksmith and Safe Repair Services 49-9094**.

TERM OF CONTRACT:

This contract will be for a period of **five (5) years**.

SERVICE TIMES:

Regular Working Hours

The Bidder shall provide 24 hours, 7 days a week emergency service to the County under this contract. During regular working hours (Monday through Friday, 8:00 A.M. to 5:00 P.M), emergency response time (defined as the time from acknowledge (by the County) to arrival on-site) shall be within two (2hours) after notification by the County.

Extending Working Hours

During hours outside of those specified above, emergency response time shall be within four (4) hours after notification by the County. On holidays observed by the County, the response time shall be within four (4) hours after notification by the County.

HOURLY RATE

The hourly rate quoted is assumed to be a straight-time rate for all labor, equipment use, travel time, and any other cost to the Bidder per person. Bidders shall not dispatch more than one (1) person per work order. The extended hourly rate shall not exceed 1 ½ times the value of the regular rate. The Bidder shall comply with minimum wage standards and any other applicable laws of the State of Florida.

LABOR AND MATERIAL CHARGES

The Bidder shall provide the County with labor and materials in strict accordance with all solicitation requirements on an as needed basis. The Bidder's cost of materials shall not exceed a 10% mark-up from the actual cost. Invoices must be submitted with actual materials costs and attached to each purchase order. If any job requires more than one person, the County shall approve of the additional person prior to the commencement of the work to be done.
