## RECOMMENDATION

It is recommended that you approve award of this contract to purchase the Mobile Carwash Services in conjunction with the needs of various Miami-Dade County Departments.

The awarded vendor will provide hand and/or power washing services for fleet vehicles including police patrol units, light to medium duty trucks, and other County vehicles as required for both the North and South Zones of Miami-Dade County.


