## RECOMMENDATION

It is recommended that you approve award of this contract for the Miami-Dade Corrections and Rehabilitation Department for purchase of frozen fruit juices.

**CONTRACT NUMBER:** FB-00373

**CONTRACT TITLE:** Frozen Fruit Juices

**TERM:** 60 months

**METHOD OF AWARD:** To the lowest priced responsive, responsible bidder in the aggregate

**PREVIOUS CONTRACT NUMBER, AMOUNT AND TERM:** 1227-4/16-4 valued at \$445,000 for five (5) years

**CONTRACT AMOUNT:** \$418,333

## BACKGROUND

The Corrections and Rehabilitation Department purchases frozen fruit juices for inmates, the current annual consumption averages of juice is as follows: 57,000 cups of orange juice, 489,000 cups of apple juice, and 66,000 cups of various other juices. All frozen fruit juices purchased under this contract must be U.S. Grade A Fancy, and each container of juice must display the Grade.

An Invitation to Bid was issued on April 27, 2016 under full and open competition. Three (3) bids were received in response to the solicitation, including one (1) "No Bid." Based on the market research conducted, which includes price and past history, the prices offered by the recommended vendor are fair and reasonable.


