

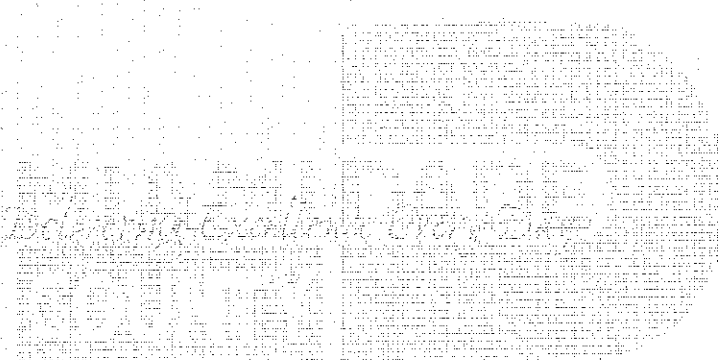
Living Wage provisions shall apply should the yearly contract total exceed \$100,000.00 throughout its term per Section 2-8.9 of the Miami-Dade County Code.
