- Fire wanted to confirm that Fire Rescue Units were not affected; wanted to confirm that all firefighter positions were budgeted
- Police hire more officers and locate them in target crime areas; establish an agricultural patrol in the South area; concern with retiring employees that have institutional knowledge
- Library concerned with hours/days; requested map of all libraries with times/days
- Budget wanted confirmation that a flat rate budget was still being proposed

Commissioner Edmonson

- CBOs requested a funding and status update; timing of RFP process
- Disparity Study issues should be added to proposed budget
- Library requested status on the opening of the Little River Library
- Small Business Development concerned with staffing levels

Commissioner Moss

- Police wanted clarification on the vacancies and recruiting classes
- Tree Canopy needs to be increased
- Summer Youth Employment request from the Federal government additional slots
- Elections wanted confirmation that there is proper funding
- South Dade Justice Center wanted confirmation that funding is allocated to take care of structural issues; requested report on timeframe for addressing other courthouse issues
- Aviation provide additional support and improvements for the Homestead airport

Commissioner Levine Cava

- Employees wanted confirmation that employees under the Mayor's purview would have their benefits restored
- Animal Services enhanced funding for spay/neuter
- Library concerned with hours/days; restoration of hours for Regional Libraries
- Sea Level Rise concerned with upcoming infrastructure improvements and if the County is prepared with additional resources to handle this issue

Commissioner Jordan

- Police wanted clarification on the vacancies, retirements, and recruiting classes; concerned with succession planning and the preservation of diversity in leadership
- Fire discussion on previous certification requirement that diminished diversity; restoration of fire training academy and partnership with the School Board
- Employees status of agreement with unions; concerned that reserve is set aside for the bargaining units without an agreement
- Parks North Glade should be included in the \$3 million funding for parks with high crime

- Transit 10 new bus technician positions is not enough to maintain aging/new fleet
- Small Business Development need liaison position in the Departments to monitor compliance; reconsider making SBD a department

Commissioner Diaz

- Police wanted clarification if the recruiting classes were lateral or new; law enforcement should be a priority in the protection of the community
- Corrections increase resources
- Fire concerned with total number of fire boats (one new) and possible UASI funding
- Animal Services discussion on the new shelter, new clinics, and no kill policy
- Transit concerned with the proposed funding; review \$3 million in savings
- Military Affairs Board continue to strengthen and grow
- Trade & Tourism continue support
- Contingency Reserve continue the reserve to reach \$100 million

Commissioner Suarez

- Real Estate Taxes \$1 million to jobs program
- Animal Services Pets Trust funding
- Employees concerned that 5 bargaining units are without an agreement
- Transit replenish PTP; discussion on the Maintenance of Effort and MDX
- Library continue in the right direction by providing additional funding
- Housing spend 1% of yearly operating budget revenue on housing

Commissioner Barreiro

• Budget – held previous meetings with the Mayor and OMB Director and communicated concerns; will continue to communicate with them

Vice Chairman Bovo

- Library create small satellite libraries in Parks
- Transit decrease reliance on PTP funding; timetable for decreased funding for operational needs

Chairman Monestime

- UMSA strong advocate
- Employees living wage for County employees; concerned about the notable difference in pay rates between service contract employees and County employees
- Small Business Development requests a more robust office
- Mom & Pop Businesses increase District allocation

- Streetscape and Right of Way Maintenance should be increased
- Transit allocate additional funding in FY15-16; discussion on the Maintenance of Effort
