# **ISSUE/REQUESTED ACTION**

Whether the Board should approve a lease agreement between Miami-Dade County and International Flight Center (IFC), for the replacement of the fixed-based operator terminal building and the construction of aircraft storage and maintenance hangars and other related aviation facilities at the Miami Executive Airport.

## PROCEDURAL HISTORY

Prime Sponsor: Commissioner Joe A. Martinez, Commission District 11 Department/Requester: Aviation Department

This item was brought before the Tourism and Ports Committee on January 15, 2020, it was forwarded to the BCC with a favorable recommendation.

# ANALYSIS

The purpose of this item is for the Board to approve a lease agreement with IFC for the replacement of the fixed-based operator terminal building and the construction of aircraft storage and maintenance hangars and other related aviation facilities at the Miami Executive Airport. The lease agreement is for a thirty-five-year term as a developmental lease agreement where IFC will invest \$6,000,000 and have an annual land, pavement, and building rental fee of \$277,773. The proposed developed is located at 14592 S.W. 129 Street at Miami Executive Airport in Commission District 11, represented by Commissioner Joe A. Martinez.

The item is silent as to the selection process utilized, other corporations submitting bids, or their ranking.

The fiscal impact is positive resulting in annual payment of \$277,773 in an annual building, land and pavement rent and \$50,789.76 in land rent.

A complete breakdown of the fiscal breakdown is illustrated in the table below:

(A) Annual Land & Building Rent: As annual land and building rent for the lease of the Premises, the Lessee shall pay to the County on the Commencement Date, the sum of \$277,773.88 annually, to be prorated and payable in equal monthly installments of \$23,147.82, plus applicable State sales tax in US funds, on the first day of each and every month, in advance and without billing, at the offices of the Lessor, as set forth in Article 3.05 (Methods of Payment). Said rental is computed as shown in Table 1 below, and is subject to annual appraisal changes:

The IFC has been a fixed based operator (FBO) on approximately 9.33 acres of land at Miami Executive Airport since October 1998. The development lease will, among other things:

- Provide for the addition of approximately 4.86 acres to the combined premises totaling approximately 14.19 acres;
- IFC will replace the existing FBO terminal building and construct two new aircraft storage hangars, a fuel farm, a maintenance hangar with office support and shop space and additional aircraft and vehicle pavement at Miami Executive Airport;
- Requires IFC to invest a minimum of \$6,000,000 for the design and construction of the proposed improvements; and
- Establishes IFC's payment requirements.





**Section 125.012 of the Florida Statutes,** Project facilities; general powers and duties - To pledge by resolution or contract the revenues arising from the operation of any project or projects owned and operated by the county to the payment of the cost of operation, maintenance, repair, improvement, extension, or enlargement of the project or projects from the operation of which such revenues are received and for the payment of principal and interest on bonds issued in connection with any such project or projects; and to combine for financing purposes any two or more projects constructed or acquired by the County.

**Florida Statutes Section 125.38** states that the Board of County Commissioners may if satisfied that such property is required for such use and is not needed for county purposes, may convey or lease the same at private sale to the applicant for such price, whether nominal or otherwise, as such board may fix, regardless of the actual value of such property. The fact of such application being made, the purpose for which such property is to be used, and the price or rent therefor shall be set out in a resolution duly adopted by such board. In case of a lease, the term of such lease shall be recited in the resolution. No advertisement shall be required.

# **ISSUE/REQUESTED ACTION**

Whether the Board should approve two separate Professional Service Agreements (PSAs) for airport fueling system services under *Contract No. E18-MDAD-01B* for the Miami-Dade Aviation Department (MDAD), each at a contract amount of up to \$3,308,250, inclusive of a contingency allowance of \$300,000 (10%) for a term of seven years.

# PROCEDURAL HISTORY

# Prime Sponsor: None Department/Requester: Aviation Department

These items were forwarded to the BCC with a favorable recommendation by the Tourism and the Ports Committee at its January 15, 2020 meeting. Prior to passage, Commissioner Jordan sought clarification of the SBE contract measures as they relate to this contract. Namita Uppal, Chief Procurement Officer (ISD) stated that the SBE contract measures are A/E at 25% and G/S at .3%.

# ANALYSIS

The purpose of this item is to establish PSAs with two Architectural and Engineering consultants, Stantec Consulting Services, Inc. (BCC Agenda Item 8A2 – File No. 192790) and T.Y. Lin International (BCC Agenda Item 8A3 – File No. 192786) to provide engineering consulting services to support all fuel facility related operations.

The funding sources for the two \$3,308,250 PSAs is Future Aviation Financing and Operating Fund under Proposed Budget and Multi-Year Capital Plan FY 19-20 Project No. 2000000096. The project scope includes design services for the upgrade, maintenance, repair and/or construction of the aviation fuel storage and distribution systems and facilities under MDAD's jurisdiction, including the following:

- Tank Farm, which handles/processes and houses the Jet-A fuel supplies for the airlines;
- Hydrant System, which transports Jet-A fuel to the ramp via underground pipelines;
- Midfield Gas Station, which dispenses vehicular fuel for airside vehicles;
- Employee Emergency Tank, which supplies vehicular fuel to airport employees in the event of a hurricane; and
- West Cargo Fuel Tender, which provides Jet-A fuel to tankers to fuel planes.

While MDAD's fueling system is in good condition, it requires specialized monitoring, testing, and upgrades and must meet regulatory compliance, thus necessitating fueling engineers for aviation fueling design services and in order to ensure uninterrupted fueling service.

Engineering services under the fueling PSAs will include the following projects:

- Inbound Filtration System Relocation;
- Fire Suppression System Design;
- One 95,600 barrel Jet Fuel Storage Tank, the construction of which will lessen the adverse impact of jet fuel supply disruptions and jet fuel inventory issues at Port Everglades;
- Fuel Facility Fire System Performance-Based Design Implementation;
- Fueling Master Plan Update; and
- Fueling Atlas Update

A 25% SBE A/E goal and .3% SBE G/S goal applied to the solicitation. The minimum qualifications required the prime consultant to have experience in planning, feasibility studies, design, and construction phase services for large commercial airport aviation fueling systems. The solicitation was advertised on October 3, 2018, yielding four respondents. The final rankings after First and Second Tier proceedings were:

- 1) T.Y. Lin International 476 points;
- 2) Stantec Consulting Services, Inc. 467 points;
- 3) Burns & McDonnell Engineering Company, Inc. 457 points;
- 4) HDR Engineering, Inc. 445 points.

The two highest-ranked firms, T.Y. Lin International and Stantec Consulting Services, Inc. are being recommended for award.

# DEPARTMENTAL INPUT

OCA posed the following questions to MDAD. The responses are delineated below in bold.

- Please explain what accounted for the delay in bringing this item before the Board, given that the solicitation was advertised in October 2018. The time it took for this A/E solicitation is fairly common, about a year. After advertisement in Dec. 2018, the final contracts awards were ready in November 2019 and processed for the December TAPS meeting. As you know the Dec. 2019 TAPS was cancelled so the items were moved to January 2020 TAPS.
- Please detail the current state of MDAD's fueling systems and the present need for these fueling system design services. Our system is in good condition, but it is a dynamic and sensitive system requiring specialized monitoring, testing, and upgrades as well as meeting regulatory compliance. It also ensures uninterrupted fueling services. For example, the following are some of the projects for which engineering services under the Fueling PSA's will be used:
  - Inbound Filtration System Relocation
  - Fire Suppression System Design
  - One 95,600 barrel Jet Fuel Storage Tank. The construction of the Jet Fuel Storage Tank will lessen the adverse impact of jet fuel supply disruptions and jet fuel inventory issues at Port Everglades.
  - Fuel Facility Fire System Performance-Based Design Implementation
  - Fueling Master Plan Update
  - Fueling Atlas Update
- Does MDAD have in-house engineers capable of providing these design services for airport fueling systems? If so, please explain the decision to contract with consultants for this purpose. The MDAD does not have in-house fueling engineers for aviation fuel design services

The Cultural Affairs Council approved the grantees at their November 20, 2019 meeting, based on the November 7, 2019 recommendations of the Community Grants Panel. Each applicant organization was evaluated based on the following criteria:

- 1) quality of the program;
- 2) administrative capability;
- 3) marketing strategy
- 4) fundraising efforts; and
- 5) geographic location of event

A total of \$660,000 was allocated for FY 2019-20 Community Grants in the Fiscal Year 2019-20 County budget ordinance. With the proposed second quarter \$190,000 disbursement, \$285,000 will remain for the subsequent quarters.

# PROCEDURAL HISTORY

**Prime Sponsor:** N/A **Department/Requester:** Fire Rescue

This item was forwarded to the BCC with a favorable recommendation by the Public Safety and Rehabilitation Committee at its January 15, 2020 meeting. Prior to passage, the following discussion transpired:

- Commissioner Martinez questioned Interim Fire Chief Alan Cominsky on whether the fire stations being built under the discussed PSA would be similar to already existing fire stations or a new model.
- Interim Fire Chief Cominsky replied that the fire stations would be of a newer, more energy efficient design.
- Commissioner Diaz asked why in-house staff could not perform the design services specified under the PSA.
- Assistant Director, Budget, Planning & Grants Management of MDFR Scott Mendelsberg replied that MDFR architects designed Stations 62 and 29 and are working on three more stations (i.e., 18, 71, and 72); given that, MDFR does not have in-house capacity to design the stations under this PSA.

#### ANALYSIS

The purpose of this item is for the Board to authorize a PSA for a maximum amount of \$891,845.40 between the County and Landera Associates, P.A. for architectural and engineering design and construction administration services for fire stations 6 and 17. That maximum amount includes a 10 percent contingency allowance of \$76,531.40. The award is for a five-year term, inclusive of a one-year warranty period. Note that the award is one of three awards on the agenda for the design of various MDFR stations.

Station 6 is located at 15890 SW 288 St., which lies in Commission District 8, represented by Commissioner Daniella Levine-Cava. Station 17 is located at 7050 NW 36<sup>th</sup> St., which lies in Commission District 12, represented by Commissioner Jose "Pepe" Diaz. These stations will replace obsolete facilities. Based on information provided by Assistant Director, Budget, Planning & Grants Management of MDFR Scott Mendelsberg, Commission District 8 currently has eight stations: Stations 6, 60, 5, 70, 55, 50, 4, and 53. Commission District 12 has eight stations: stations 46, 28, 69, 45, 48, 17, 29 and 58.

OCA sent an inquiry to MDFR on January 7, 2020; MDFR responded on January 8, 2020 and the response is shown in bold.

• Please indicate whether the requested architecture and engineering services can be performed in-house and the number of architects and engineers MDFR has on staff. If so, why is a consultant being hired to perform the work? Miami-Dade Fire Rescue currently has two architects on staff. One is the Facilities Maintenance and Construction Division Manager who will be retiring in July. We will attempt to fill the position with someone who is a registered architect or professional engineer, but it has not been a historical job requirement. MDFR used in house staff to design station 62, recently opened and completed in Palmetto Bay, and also designed Station 29 in Sweetwater, a rebuild of an existing station that will be complete later this year. Additional projects slated for in-house design this year include Station 18 in North Miami, Station 71 on Eureka Drive in south Miami-Dade and Station 72 in Florida City. With those three new station projects being done in house, MDFR will not have the capacity to concentrate on the fire station rebuilds and therefor is seeking the services of private sector Architectural and Engineering firms to complete the work. Each firm selected has previously completed fire station designs for MDFR. Alleguez Architecture previously designed Station 64 in Miami Lakes and MDFR's first solar powered fire station, station 68, that is about to be put out for construction bids. There are two more A/E PSAs with other firms to design 4 additional rebuilds that should be accompanying this one.

# **ISSUE/REQUESTED ACTION**

Whether the Board should approve a Professional Services Agreement (PSA) between the County and Alleguez Architecture, Inc. for *Project No. A18-MDFR-01-A*, for architectural and engineering design and construction administration services of Miami-Dade Fire Rescue Stations 4, 5 and 63 in a total amount not to exceed \$1,470,900, inclusive of a \$126,900 contingency allowance, for a five-year term.

This item was heard at the Public Safety and Rehabilitation (PSR) Committee meeting of January 15, 2020 and forwarded to the BCC with a favorable recommendation.

# ANALYSIS

The purpose of this item is for the Board to authorize a PSA for a maximum of \$1,470,900 between the County and Alleguez Architecture, Inc. for architectural and engineering design and construction administration services for fire stations 4, 5 and 63. That maximum amount includes a 10% contingency allowance of \$126,900. The award is for a five-year term, inclusive of a one-year warranty period. Note that the award is one of three awards on the agenda for the design of various MDFR stations.

Station 4 is located at 9201 SW 152 St., and Station 5 is located at 13150 SW 238 St., both of which lie in Commission District 8, and represented by Commissioner Daniella Levine Cava. Station 63 is located at 1655 NE 205 St., which lies in Commission District 1, and represented by Commissioner Barbara J. Jordan.

Under the PSA, the consultant agrees to provide complete professional architectural and engineering services for the five-phase project, including all civil and structural engineering, interior design, mechanical and plumbing, electrical, landscape and LEED design and certification. The Project Phases are: (1) Site Investigation, Programming and Schematic Design; (2) Design Development; (3) Construction Documents Development; (4) Bidding and Award of Contract; and (5) Administration of the Construction Contract.

Key services to be provided by the consultant as delineated in the Scope of Services are:

- Submit full architectural and engineering services necessary to prepare the Architectural Program, Construction Plans and Specifications, and Bid Documents, et al
- Assess current site conditions
- Develop technical specification and constructions documents
- > Develop furniture, fixtures and equipment recommendations and schedule

- Indicate on floor plans the location of all items
- Provide estimates of probable construction costs

There are six subconsultants as set forth in the mayoral memorandum: SRS Engineering, Inc., Bliss & Nyitray, Inc., SDM Consulting Engineers, Inc., Laura Llerena & Associates, Inc., J. Bonfill & Associates, Inc., and Nutting Engineers of Florida, Inc. Of the six subconsultants, two are certified SBEs. The PSA includes an SBE 32% goal.

The Notice to Professional Consultants (NTPC) was advertised on March 8, 2019. A total of 11 proposals were received by the April 19, 2019 submittal deadline. The NTPC has three groups – A (Stations 4, 5 and 63), B (Stations 6 and 17) and C (Stations 9 and 19). Group A Stations 4, 5 and 63 are the subject of this award to Alleguez Architecture, Inc. The County Mayor's designee approved the Negotiations Committee recommendation on July 8, 2019 and negotiations were completed for Group A on October 24, 2019. Table 1 provides the ranking of the top firms and their total qualitative points.

OCA reviewed the Capital Improvements Information System on January 7, 2020 and found nine evaluations for Alleguez Architecture, Inc., with an average rating of 3.5 out of a possible 4.0. According to the mayor's memo, Alleguez Architecture Inc., the prime consultant, holds the following certifications: Architecture; Architectural Construction Management; and ADA Tile II Consultant.

OCA performed a search for commodity codes 9.02 (Soils, Foundations and Materials Testing-Geotechnical and Materials Engineering Services); 10.01 (Environmental Engineering-Stormwater Drainage Design Engineering Services); 15.01 (Surveying and Mapping-Land Surveying); and 15.03 (Underground Utility Location) on the Business Management Workforce System (BMWS) on January 8, 2020. There were 63 local firms with at least one of the required technical certifications listed.

Note: Not all commodity codes listed in the mayor's memo were available for viewing via BMWS.

OCA sent an inquiry to MDFR on January 7, 2020; MDFR responded on January 8, 2020 and the response is shown in bold.

• Please indicate whether the requested architecture and engineering services can be performed in-house and the number of architects and engineers MDFR has on staff. If so, why is a consultant being hired to perform the work? Miami-Dade Fire Rescue currently has two architects on staff. One is the Facilities Maintenance and Construction Division Manager who will be retiring in July. We will attempt to fill the position with someone who is a registered architect or professional engineer, but it has not been a historical job requirement. MDFR used in house staff to design station 62, recently opened and completed in Palmetto Bay, and also designed Station 29 in Sweetwater, a rebuild of an existing station that will be complete later this year. Additional projects slated for in-house design this year include Station 18 in North Miami, Station 71 on Eureka Drive in south Miami-Dade and Station 72 in Florida City. With those three new station projects being done in house, MDFR will not have the capacity to concentrate on the fire station rebuilds and therefor is seeking the services of private sector Architectural and Engineering firms to complete the work. Each firm selected has previously completed fire station designs for MDFR. Alleguez Architecture previously designed Station 64 in Miami Lakes and MDFR's first solar powered fire station, station 68, that is about to be put out for construction bids. There are two more A/E PSAs with other firms to design 4 additional rebuilds that should be accompanying this one.

# **DEPARTMENTAL INPUT:**

OCA asked the following question on January 7, 2020, the department response is in bold below:

• Please indicate whether the requested architecture and engineering services can be performed in-house and the number of architects and engineers the County has on staff that can perform such duties.

Miami-Dade Fire Rescue currently has two architects on staff. One is the Facilities Maintenance and Construction Division Manager who will be retiring in July. We will attempt to fill the position with someone who is a registered architect or professional engineer, but it has not been a historical job requirement. MDFR used in house staff to design station 62, recently opened and completed in Palmetto Bay, and also designed Station 29 in Sweetwater, a rebuild of an existing station that will be complete later this year. Additional projects slated for in-house design this year include Station 18 in North Miami, Station 71 on Eureka Drive in south Miami-Dade and Station 72 in Florida City. With those three new station projects being done in house, MDFR will not have the capacity to concentrate on the fire station rebuilds and therefor is seeking the services of private sector Architectural and Engineering firms to complete the work. Each firm selected has previously completed fire station designs for MDFR. Alleguez Architecture previously designed Station 64 in Miami Lakes and MDFR's first solar powered fire station, station 68, that is about to be put out for construction bids. There are two more A/E PSAs with other firms to design 4 additional rebuilds that should be accompanying this one.

#### **ISSUE/REQUESTED ACTION**

Whether the Board should approve a lease agreement between Miami-Dade County and Gateway Airport Concessions, Inc. for the use of County-owned property at the Joseph Caleb Center for operation of a restaurant for a 10-year and six-month term with a positive fiscal impact to the County of at least \$217,819.

#### PROCEDURAL HISTORY

Prime Sponsor: Chairwoman Audrey M. Edmonson, District 3 Department/Requester: Internal Services

This item was brought before the Health Care and County Operations Committee on January 16, 2020 and forwarded to the BCC with a favorable recommendation.

#### ANALYSIS

The purpose of this item is to seek Board authorization for the award of a lease agreement to Gateway Airport Concessions, Inc. for the operation and maintenance of a food service facility at the Joseph Caleb Center. The Caleb Center, which is located at 5400 NW 22 Avenue in District 3, is a neighborhood center featuring a 962-seat theater and an office complex. The restaurant space being leased is on the first floor of the Caleb Center and is approximately 2,600 square feet.

The lease agreement is for a 10-year and six-month term and will generate revenue to the County totaling \$217,819. The total rental revenue equals \$217,819 after reimbursement of up to \$50,000 to Gateway for improvements to the premises. Gateway is required to pay a security deposit, in the amount of \$6,000, equivalent to three months' rent within 10 days following the lease agreement effective date. Such improvements may consist of countertops, kitchen equipment, plumbing, electrical connections, light fixtures and cabinetry. The \$50,000 to be amortized over the initial five years of the lease in the form of a monthly rent credit not to exceed \$666.66 per month. The rental revenue to the County for the first two years of the lease term is \$24,000 annually, which is to be paid in equal monthly payments of \$2,000. Commencing on the first day of the third lease year, and every year thereafter, the rental revenue will be increased by three percent. The table below displays the rent obligations under the lease agreement, including the three percent escalation and the rent credit, based on information taken from Article 14 of the lease agreement.

This lease award is the result of a competitive procurement process. The County issued RFQ-01113 for the Lease/Operation of a Restaurant at the Joseph Caleb Center on November 14, 2018. The purpose of the solicitation was for the County to contract with an experienced firm for the lease, development, operation and maintenance of 2,600 square feet of retail space at the Joseph Caleb Center for the operation of a fast food restaurant. Proposals were due on January 25, 2019. Three entities responded to the solicitation – Elia Mediterranean Products, LLC; Frazier Enterprises of Miami Gardens, Inc.; and Gateway Airport Concessions. The restaurant space at the Caleb Center has been closed for approximately five years due to construction of a new parking garage, parking lot improvements and renovations to the building. Under the RFQ, the lessee is responsible for any improvements to the restaurant required to make the space suitable for its operations. Key operational requirements of the lessee under the RFQ are to:

- Operate a fast food/casual cafeteria or deli-style restaurant with the purpose of serving the Caleb Center employees and the public, with top quality food at fair, affordable prices (\$10 and under);
- Provide multiple payment options to its clientele, including cash, credit card and debit card;
- Employ a qualified full-time on-site manager having experience in the management of a restaurant or similar type of food service operation;
- Provide secure Wi-Fi services as required to conduct business operations; and
- Obtain a grease, oils and fat discharge permit and maintain the grease trap and exhaust system as required by County Ordinance.

The lease agreement provides that upon receipt of the security deposit and lessee's insurance certificate for insurance requirements, the landlord will issue a Notice to Proceed, which will allow the lessee to enter and begin occupying and proceeding to build-out the leased premises. Lessee shall operate the restaurant, at a minimum, five days a week Monday through Friday from 7am to 5pm except on County, state and federal designated holidays.

Note that Article 3 of the lease agreement authorizes Gateway to operate a temporary food service facility within the Caleb Center prior to the date of beneficial occupancy; no rent will be required for this temporary food service. After the date of beneficial occupancy, the temporary facility shall be discontinued. Other responsibilities under the lease agreement have been summarized below.

# **ISSUE/REQUESTED ACTION**

Whether the Board should approve the award of Group Nos. 1 and 2 under *Contract No. FB-01363* for the purchase of bakery products for the Community Action and Human Services and Corrections and Rehabilitation departments for a maximum amount of \$1,853,966 for a five-year term.

#### **PROCEDURAL HISTORY**

This item was heard at the Health Care and County Operations Committee (HCCO) meeting of January 16, 2020 and forwarded to the BCC with a favorable recommendation.

# ANALYSIS

The purpose of this item is to establish a long-term replacement contract for the Community Action and Human Services and Corrections and Rehabilitation departments to purchase bakery products, such as loaves of bread, buns, rolls and hoagies, on an as-needed basis to satisfy their operational requirements. The contract is valued at up to \$1,853,966 for a five-year term and includes two groups, i.e., Group No. 1 (Non-Federally Funded for Loaves of Bread, Buns and Rolls and Hoagie Bread) and Group No. 2 (Federally Funded for Loaves of Bread and Buns). Note that though Group 3 (Federally Funded for French Bread) was also solicited, no bids were received for that group. Hence, Group 3 is not included in this contract award.

The method of award for this contract was to the lowest-priced, responsive and responsible bidder on a group-bygroup basis in the aggregate who met the solicitation's qualifications. The qualifications are as follows:

- Bidder shall submit a copy of a valid state or local permit/certificate/license confirming authorization to provide the solicited services;
- Bidder shall submit a copy of its most recent food safety and employee health reports;
- Bidder shall provide proof that it receives pest control services at its business facility; and
- Bidder shall provide at least three client references for comparable services.

It is important to mention that for Group 1 there is an additional qualification – bidder shall have a facility located within the tri-County area.

The solicitation was advertised on August 23, 2019, and the bid open date was September 24, 2019. Two bids were received in response to the solicitation for Groups 1 and 2. The respondents are Flowers Baking Co. of Miami LLC (the recommended awardee) and Bimbo Bakeries USA, Inc. (an incumbent under the current contract that was deemed non-responsive for this award). Bimbo Bakeries USA, Inc., located in Medley, Florida, was deemed non-responsive by the County Attorney's Office for taking material exception to the delivery requirements of the solicitation.

The deliveries under this solicitation are to be made to the following locations as depicted in the table below:

The fiscal impact is \$1,853,966 for the five-year replacement term. The bulk of the allocation (\$1,833,003) is slated for the Corrections and Rehabilitation Department. The current contract, *No.* 8929-1/19, is valued at \$10,501,236 for a 10-year and six-month term. The annual allocation under the replacement contract is \$370,793.20 while the annual allocation under the current contract is \$1,000,117.68. This represents a nearly 63% percent decrease. The mayoral memorandum suggests that the allocation under the replacement contract is lower than the current contract due to lower quantities of bakery products ordered on an annual basis since the current contract's inception.

The current contract is set to expire on February 29, 2020. The expiration date reflects a six-month administrative extension from the original expiration date of August 31, 2019 to the current February 29, 2020 date. Resolution No. R-718-17 requires that planning reprocurement commence no later than 18 months prior to the expiration of contracts and prequalification pools for purchases of goods or services. To have prevented a need for an administrative extension, pursuant to the resolution, reprocurement activities for this contract should have begun February 2018.

OCA conducted a review of the Bid Tracking System (BTS) on January 29, 2020 and found the current contract, which is in its option term, had an allocation of \$5,110,618, of which \$2,331,647.03 has been released, leaving a balance of \$2,778,970.97. As previously indicated, there is less than a month left in the option term.

The mayoral memo provided the commodity codes for this item. OCA performed a search for commodity code 37515 (Bread, Rolls, etc.) on the Business Management Workforce System's Certified Vendor Directory on January 27, 2020. Listed below are the local SBEs identified:

The current contract, *FB-00052, Medical, Industrial Gases and Related Items*, established by Resolution No. R-805-14 on September 16, 2014 for a five-year term in the cumulative amount of \$2,093,000, is currently in the last year of its option term. Accounting for modifications, the cumulative value of the pool, including the option term, is currently \$2,302,299, of which \$1,696,091 has been released, leaving a balance of \$606,207 (as of January 27, 2020). The replacement contract's allocation of \$1,316,950 is lower than that of the current contract due to Group 11 not being awarded in the contract.

The current contract expires on April 30, 2020, after approval of a six-month extension. The original expiration date was October 31, 2019. Pursuant to Resolution No. R-718-17, the County is required to commence planning for reprocurement of contracts and prequalified vendor lists that are set to expire no later than 18 months prior to expiration. Given the current pool's original expiration date, the County is required to have commenced planning for reprocurement no later than April 30, 2018.

The solicitation was issued and advertised, with notification to 1,589 vendors and seven vendors responding. Of the seven respondents, two indicated that they will not be providing an offer and were therefore deemed "no bids". Four of the respondents are being recommended for award, all of which have local addresses, and three of which are incumbents (the current contract has four awardees). Given that no proposals were received for Group 11, the County will resolicit or access other agencies' contracts for this procurement.

#### **ISSUE/REQUESTED ACTION**

Whether the Board should authorize the establishment of *Prequalification Pool No. RTQ-01286*, for the purchase of Dell brand hardware, software and professional services, in the amount of \$5,460,000 for a term of five years, for the Information Technology Department.

#### PROCEDURAL HISTORY

Prime Sponsor: None Department/Requester: Internal Services Department (ISD)

This was heard at the Health Care and County Operations Committee (HCCO) meeting of January 16, 2020 and forwarded to the BCC with a favorable recommendation. Previously, this item was carried over from the HCCO meeting of December 12, 2019 due to lack of quorum.

#### **ANALYSIS**

The purpose of this item is to gain Board authorization to establish *Prequalification Pool No. RTQ-01286* in the amount of \$5,460,000 for a five-year term to enable the County to continue purchasing Dell hardware, software and cloud solutions as well as professional, maintenance and support services. This long-term replacement pool supports the County's vast information technology infrastructure. The Information Technology Department will manage this pool on behalf of County departments. In order to qualify for the pool, the vendor must submit a letter from Dell documenting that it is part of Dell's Partner Direct Program at the Gold, Platinum or Titanium level. Additionally, the vendor shall provide a business contact who will be responsible for responding to County-issued spot market quotes.

The fiscal impact of \$5,460,000 for the five-year replacement term is broken down on the departmental level as follows:

- ✤ ITD for County departments: \$2,500,000;
- ✤ Library System: \$2,860,000; and

The annual allocation under the replacement pool is \$1,092,000 while the annual allocation under the current pool is \$618,462. The mayor's memorandum attributes the replacement pool's higher allocation to estimated usage and the longer term.

OCA examined the current pool's Blanket Purchase Order (BPO) in the Bid Tracking System (BTS) on January 31, 2020. The BPO shows a zero balance. There are less than two months remaining on the pool.

A total of nine vendors responded, including one "No Bid." Of those nine vendors, five have met the prequalification criteria and are being recommended for inclusion in this pool. Only one of the five recommended vendors has a local address. The recommended vendors are listed below. An asterisk (\*) denotes the local vendor.

## **PROCEDURAL HISTORY**

The item was originally scheduled for the December 12, 2019 Health Care and County Operations Committee (HCCO) meeting; however, the item was carried over due to a lack of quorum. Subsequently, the item was placed on the January 16, 2020 HCCO meeting agenda wherein it was forwarded to the BCC with a favorable recommendation.

#### ANALYSIS

The purpose of this item is to gain Board approval of a replacement contact for vehicle rental services to support the operational requirements of multiple County departments. The contract value for the five-year term is \$28,314,600. The contract provides a variety of vehicle classifications to meet the County's rental needs. Vehicle classes include, but are not limited to, economy, compact, intermediate, premium, luxury, cargo van, passenger minivan, standard SUV and standard pickup.

Under the solicitation, the method of award was to multiple responsive and responsible bidders who met the qualification criteria in the aggregate (i.e., daily, weekly, monthly and bi-annual rates) based on the lowest-fixed rental rates per vehicle class. County staff shall issue purchase orders to the awarded bidder with the lowest fixed rate per required vehicle class. If that bidder is unable to meet the purchase order requirements, staff may then order from the next lowest awarded bidder offering the same vehicle class. To be qualified for award, the bidder shall be regularly engaged in the business of providing contracted vehicle rental services to government agencies and/or private corporations. The bidder shall also provide the contact information of a designated representative to furnish the County with information and support concerning rental vehicles.

The fiscal impact is \$28,314,600 for a five-year term, \$254,400 less than the current contract 8809-0/19 which is valued at \$28,569,000 and set to expire on May 28, 2020. The biggest user department under this award is Police, requesting a total of \$16,864,000 for the term, representing more than 50% of the contract value. The allocation under the replacement contract is slightly lower than the cumulative allocation of the current contract based on the departments' projected usage.

The current contract (No. 8809-0/19) was awarded on February 2, 2015 for a five-year and three-month term and is set to expire on May 28, 2020. The expiration date reflects a three-month administrative extension, i.e., from the original expiration date of February 28, 2020 to May 28, 2020. As of January 28, 2020, the contract's Blanket Purchase Order

shows that \$21,102,951.68 of the \$28,569,000.00 allocation has already been released, leaving a balance of \$7,466,048.32 with four months left on the contract.

As per Resolution No. R-718-17, re-procurement of the contract should have commenced no later than September 2018, 18 months before the original expiration of the contract on February 28, 2020.

The replacement solicitation was advertised on September 19, 2019. Two vendors responded to the solicitation, and both of those vendors (Royal Rent A Car Systems of Florida Inc. and Enterprise Leasing Company of Florida LLC) are being recommended for award. Note that the recommended vendors are contract incumbents.

OCA performed due diligence on the two awarded firms, Royal Rent A Car Systems of Florida Inc, and Enterprise Leasing Company of Florida LLC, on December 10, 2019. The findings are summarized in the table below:



# PROCEDURAL HISTORY

This item was forwarded to the BCC with a favorable recommendation by the Health Care and County Operations Committee at its January 16, 2020 meeting.

# ANALYSIS

The purpose of this item is to establish a prequalification pool for solid waste hauling and disposal services for use by DSWM on an as needed basis. The total allocation for the five-year term is \$37,400,000. Vendors in the pool will utilize their own tractor trailers to haul solid waste from a County facility to a designated disposal facility and are responsible for all components and costs related to operation and maintenance of the tractors for this purpose. DSWM is in need of these services to preserve the capacity of its landfill and as a backstop in the event of an emergency, e.g., a catastrophic hurricane, or a fire or mechanical event at DSWM's Resources Recovery Facility (RRF). DSWM currently has disposal capacity agreements with landfills out of the County. This pool would provide the missing component needed—contracted vehicles to transport and dispose municipal solid waste to these out of County landfills.

There is no current County contract for these services. DSWM has contracted similar services in the past for hurricane debris cleanup, but not for day-to-day long-hauling and disposal of municipal solid waste.

A Request to Qualify was issued and advertised, with six vendors responding. Of the six respondents, one indicated that it will not be providing an offer and was therefore deemed a "no bid". Three of the respondents are being recommended for inclusion in the pool, all of which are local vendors. Vendors may be added to the pool at any time, and additional outreach is being conducted to encourage participation.

# **DEPARTMENTAL INPUT**

The Office of the Commission Auditor posed the following questions to the Department of Solid Waste Management. The responses are delineated in bold.

- Has the County ever contracted for these services in the past? Not to my knowledge. We have done so for hurricane debris cleanup, but not for day-to-day long-hauling and disposal of municipal solid waste (MSW).
- Why is there a current need for these services? We will use this pool contract as 'insurance' in case, for example, of a catastrophic hurricane, fire or mechanical event at our Resources Recovery Facility (RRF), where we currently process ~1 million tons of MSW every year. We have disposal capacity agreements in landfills out of the county, but no contractual vehicle to transport and dispose. This pool would provide the missing component.
- Why does the award value differ from the advertised value of \$36.4 million, as seen in the County's Bid Tracking System? **Response currently pending.**

## ANALYSIS

The purpose of this item is to approve the budget for Fiscal Year 2019-20 for the South Miami Community Redevelopment Agency (CRA) and the South Miami Community Redevelopment Area (Area), totaling \$3,593,089. The Interlocal Agreement between the CRA and the County requires that the Agency's annual budget be approved by the Board of County Commissioners prior to the Agency expending any funds. The previous budget for Fiscal Year 2018-19 was approved by the Board pursuant to Resolution No. R-54-19 on January 23, 2019 in the amount of \$3,443,980. The CRA's Fiscal Year 2019-2020 budget was approved by the Agency on August 6, 2019 and by the City of South Miami on August 20, 2019.

The South Miami Community Redevelopment Agency is an urban initiative established on June 16, 1998 to address documented slum and blight conditions in the City of South Miami by improving the physical environment and quality of life in the redevelopment area. The CRA is a neighborhood development agency in Commission District 7, represented by Commissioner Xavier L. Suarez. The CRA's geographic area is generally described as being bounded by SW 62nd Avenue on the West, SW 62nd Street on the North, SW 57th Avenue on the East, and SW 72nd Street on the South. The specific goals of the CRA continue to be the increase of property values within the area, the provision of enhanced safety to the area's residents in the form of community policing, and the identification of opportunities to improve the physical quality of life for the businesses and residents of the area in accordance with the Community Redevelopment Plan. Note that the CRA is currently scheduled to sunset on June 1, 2020. Based on correspondence with South Miami CRA Director Evan Fancher, the South Miami CRA will meet on February 3, 2020 to decide whether or not the CRA's existence will be extended.

The requestor Department also submitted a status update on four of the six SMART Plan corridors, as well as the BRT Network component. Below is a brief synopsis of each one.

- ✤ East-West Corridor 11 miles (FIU-Miami Intermodal Center, MIA)
  - The project team will coordinate with the Federal Transit Administration (FTA) after the selection of the Locally Preferred Alternative (LPA). The final National Environmental Policy Act (NEPA) document should be completed in early 2020.
- South Corridor 20 miles (Florida City-Dadeland South Metrorail Station)
  - The project team submitted a Small Starts Package to the FTA, requesting \$100 million FTA Capital Investment Grant Program funding in August 2019, and is expecting a grant agreement with FTA in April 2020.
- Beach Corridor 11.5 miles (Miami Design District-Downtown Miami-MacArthur Causeway-Miami Beach Convention Center)
  - The County issued an RFP for a Rapid Mass Transit Solution for the Beach Corridor Trunk Line in September 2019 and is expected to receive proposals in March 2020. DTPW initiated the environmental, geotechnical and utility explorations to provide data to potential proposers.

The Commission, by two-thirds (2/3) vote of the members present, may waive the requirements of this section. The foregoing notwithstanding, the requirements of this section shall not apply to contracts or purchases which the County Manager has the delegated authority to award under Section 2-8.1(b) of this Code.


## ANALYSIS

The purpose of this item is to facilitate FDOT's construction of improvements on SW 211th Street at SR 989/Allapattah Road/SW 112th Avenue, within the County's right-of-way, via an Off-System Construction and Maintenance Agreement—required due to the road not being on the State Highway System. The construction of this project, which is located in Districts 8 and 9, will be at no cost to the County, as the estimated cost of \$250,000 for the improvements in the defined County area will be funded by FDOT. The County is, however, responsible for providing maintenance operations within the County's right-of-way upon project completion. FDOT's construction cost for the overall project is \$1.2 million, the scope of which includes the following:

- Milling and resurfacing of SR 989;
- Widening SR 989 to provide a northbound dual left turn lane and extend northbound right turn lane;
- Milling and resurfacing of SW 211th Street for approximately 300 feet east and west of the SR 989 intersection;
- Minor widening at SW 211th Street median to extend the westbound left turn lane;
- Signalization improvement at the intersection of SR 989 and SW 211th Street;
- Modifications of drainage to address new conditions on SR 989; and
- Upgrading and adding new signing and pavement markings, and traffic signage.

FDOT will complete all aspects of the project, including the design, construction, construction inspection, utilities, and securing of permits and easements.

Construction will necessitate temporary workday lane closures during non-peak hours in order to minimize the effect on traffic. Access and egress to and from adjacent neighborhoods and businesses as well as pedestrian traffic will not be interrupted. According to FDOT's Project Fact Sheet, work is expected to begin July 2021, with completion expected March 2022. A public meeting regarding the project was held on September 12, 2018 at the South Dade Regional Library.

#### ANALYSIS

The purpose of this item is to attain the Board's ratification for a construction contract award for Consent Decree Project No. 5.9 Upgrade and Replacement of Regional Pump Station 0301, Contract No. S-940 to Lanzo Construction Co., Florida, in the amount of \$9,051,628.00 for a term of 935 days.

On September 3, 2014, the Board approved Ordinance No. 14-77 authorizing the County Mayor to award contracts for funded projects and related goods and services, to reject bids and proposals received in connection with any competitive procurement, and to accelerate the approval of WASD's (1) Consent Decree projects and (2) projects identified in WASD Multi-Year Capital Plan's Capital Improvements Program without the need for prior Board approval, but subject to ratification by the Board.

The Miami-Dade Water and Sewer Department Consent Decree Work consists of all projects needed to comply with the Consent Decree approved on April 9, 2014, by the United States District Court for the Southern District of Florida. The Miami-Dade Water and Sewer Department Capital Improvement Program consist of only those projects approved by the Board as part of the Multi-Year Capital Plan. The Compliance date for Consent Decree project 2.11 is May 9, 2020.

The Fiscal Impact to the County for the implementation of this contract will be of 9,051,628.00 and impacts Commission District 4, represented by Commissioner Sally A. Heyman.

This project is one in a series of projects processed under Section 2-8.2.12 of the Code, which governs the Miami-Dade County Water and Sewer Department Consent Decree and Capital Improvement Programs Acceleration Ordinance. Scope of services includes, furnishing all materials, all labor, and all equipment necessary to replace Regional Pump Station 0301 with a new pump station. The project consists of demotion of the existing pump station and variable frequency driven motors, piping, and equipment in the wet well; valves, piping and fitting (including stainless steel plug and check valves); a flow meter and flow control; manholes; and odor control system; construction of an electrical and generator building; a generator set and an above ground fuel tank, hoist and trolley systems, including monorail support system; wooden perimeter fence and access gate; and all required by-pass pumping.

On May 21, 2013, the Board of County Commissioners authorized the execution of a Consent Decree between Miami-Dade County, the United States of America, the State of Florida and the Florida Department of Environmental Protection, for improvements to the County's wastewater collection and treatment system. WASD determined that the Central District Waste Water Treatment Plant (CDWWTP) requires replacement and/or upgrade of pump motors and their associated drives and electrical power and control systems. Improvements to the facilities are required pursuant to the Consent decree from the U.S. Environmental Protection Agency (U.S. EPA), Department of Justice (DOJ) and the Florida Department of Environmental Protection (FDEP), Case No 1:12-cv-24400-FAM.

On July 12, 2019, in response to WASD's competitive solicitation for Project No. S-940, the department received nine bids. The respondents were 1) Lanzo Construction Co., Florida, 2) Kiewit Infrastructure South, Co., 3) David Mancini & Sons, Inc., 4) Daniel O' Connell's Sons, Inc., 5.) Comtech Engineering, Inc., 6.) OCA conducted a review of the following commodity codes: 15010 (Construction Materials), 65800 (Pipe, Tubing and Accessories), 237110 (water and Sewer Line and Related Structures Construction), 236220 (Commercial and Institutional Building Construction), 238210 (Electrical Contractors and Other Wiring Installation Contractors) 237990 (Other Heavy and Civil Engineering Construction), 238320 (Painting and Wall Covering Contractors), 238220 (Plumbing, Heating, and Air-Conditioning Contractors,), 238120 (Structural Steel and Precast Concrete), and 238160 (Roofing Contractors) in the Business Management Workforce System on January 29, 2020. OCA contacted WASD on January 29, 2020 and asked the following questions below.

1. Does WASD have a list of potential pump stations that may have exceeded their useful life and are potentially liable for a sewage spill? If so, can WASD provide that list?

WASD proactively conducts and prioritizes its maintenance program through continual monitoring of system performance through various means, including a robust Supervisory Control and Data Acquisition (SCADA) that contains more than 96,000 signals. Additionally, to manage such a complex system, WASD has undertaken a multifaceted, proactive approach for the maintenance, rehabilitation, replacement, and upgrades to the system's assets.

- Mortality (useful life). 0
  - Useful life for a pump station is typically estimated at 25 years but this can be influenced/effected by numerous factors.
  - Maintenance and/or upgrades may be implemented earlier or later depending on particular • conditions and circumstance.
  - The Department monitors condition to ensure equipment is operable, regardless of age.
  - Capacity (NAPOT, SCADA, Hydraulic Modeling)
- Efficiency (energy, operating costs, obsolescence, etc.)
- Level of service (reliability, resilience, and regulatory)
- Consequence assessment (triple bottom line evaluation)
- 2. During the Sewage spill of April 2019, rags were found inside the pumps, does WASD have any system that captures and/or filters out this type of debris?

We are using several technologies to address the issue of rags at the pump stations. One of them is the de-ragger, which operated the pumps impellers in such a way (slowing it down, reversing rotation, etc.) that it prevents the rags from getting tangled on it causing the pumps' failure, we also have the no clog pumps that basically eliminated the impeller reducing significantly any possibility of clogging of the pump and we are evaluating grinder pumps that shred the rags as they move through the impeller and the use of screens at certain pump stations.

The spill occurred in early February 2019.

3. The Scope of Services for this project references "hoist and trolley systems, including monorail support system;" can WASD elaborate as to what these components are for?

These are overhead systems to assist in the maintenance, installation, and removal of pumps and equipment.

4. How will the homes served by pump station 301 sustain service while the replacement is conducted? Does WASD foresee this replacement resulting in prolonged interruption of sewer service to customers in this area? We do not foresee any interruption of sewer service to customers in the area since existing pump station 301 will remain in service during construction of the new pump station.

Section 2-8.2.12(4)(d) and (e) of the County Code (WASD Consent Decree) provides for the acceleration of Miami-Dade Water and Sewer Department Consent Decree and Capital Improvement Program projects, establishes policies and procedures for the approval of contracts related to those projects, specifically the right to amend contracts and extend the time for completion of any contract for construction, materials or professional services, including waivers of liquidated damages and other compensable and/or non-compensable time extensions as well as to negotiate and settle claims, and issue settlement agreement(s) or change orders for additional work under contracts and amendments where: the change order or claim does not exceed ten percent (10%) of the base contract amount, and the contingency allowance shall be utilized to ensure minimal disruption in work flow and shall be documented on the appropriate contingency authorization draw. Change orders shall be submitted to replenish the contingency account in a timely manner; and the limitations provided in (4)(e)(i) above shall not apply to any change order or amendment related to emergency actions impacting remediation, public safety, health requirements or recovery from natural disaster.
