RESOLUTION APPROVING AWARD OF CONTRACT NO. FB-01356 TO NEW FLYER OF AMERICA, INC. FOR THE PURCHASE OF 140 LOW-FLOOR HEAVY DUTY 40-FOOT COMPRESSED NATURAL GAS BUSES FOR THE DEPARTMENT OF TRANSPORTATION AND PUBLIC WORKS WITH AN AMOUNT NOT TO EXCEED \$74,548,600.00, FOR A FIVE-YEAR TERM; AND AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO GIVE NOTICE OF THIS AWARD, ISSUE THE APPROPRIATE PURCHASE ORDERS TO GIVE EFFECT TO SAME AND EXERCISE ALL PROVISIONS OF THE CONTRACT PURSUANT TO SECTION 2-8.1 OF THE CODE OF MIAMI-DADE COUNTY, FLORIDA AND IMPLEMENTING ORDER 3-38; AND AUTHORIZING THE USE OF CHARTER COUNTY TRANSPORTATION SURTAX FUNDS FOR THIS PROJECT WHICH WAS IN THE ORIGINAL EXHIBIT 1 OF THE PEOPLE'S TRANSPORTATION **PLAN**

ISSUE/REQUESTED ACTION

Whether the Board should approve an award of Contract No. FB-01356 to New Flyer of America, Inc. for the purchase of 140 low-floor, heavy duty 40-foot compressed natural gas (CNG) buses in a total amount up to \$74,548,600 for the Department of Transportation and Public Works (DTPW) for a five-year term, authorizing the use of Charter County Transportation Surtax funds for such purpose.

PROCEDURAL HISTORY

Prime Sponsor: None

Department/Requester: Internal Services Department (ISD)

There is no procedural history for this item.

ANALYSIS

The purpose of this item is for the County to acquire 140 CNG-powered low-floor 40-foot buses from New Flyer of America, Inc. (New Flyer) to replace buses that have exceeded their useful life. This item is specifically requesting \$74,548,600 to cover this purchase for the five-year term. Charter County Transportation Surtax and Lease Financing funds are the funding sources; however, the item is silent as to the exact portion of the purchase that will be funded by surtax dollars.

Under the solicitation, the method of award was to the responsible and responsive bidder for either Option 1 (i.e., award of 140 buses to the lowest bidder who delivers all buses no later than August 31, 2020 when the total bid price is lower by \$1 million or more when compared to the lowest combined bid prices for Option 2) or Option 2 (i.e., award of 140 buses to the lowest two bidders for 70 buses each who deliver all buses no later than June 30, 2020). Additionally, the solicitation sets forth that awarded prices shall be fixed and firm for the term of the contract with no price adjustments. Relating to technical specifications, the solicited buses shall have a minimum expected life of 12 years or 500,000 miles.

On June 18, 2019, an item recommending the purchase of 140 CNG buses in an amount of \$80,938,454 via accessing a Commonwealth of Virginia contract was 4-day ruled by the BCC. Under the proposed contract, Gillig would provide 40 buses, and New Flyer would provide 100 buses (see Legistar File No. 191268). The County sought to access this contract to capitalize on economy of scale pricing and an accelerated delivery schedule to meet DTPW's needs.

Ultimately, the item was removed from the July 10, 2019 BCC agenda (Item 8F21) due to a lack of motion or second. As such, the purchase was not approved.

In lieu of the above access contract as an avenue to purchase 140 CNG buses, the County advertised *Contract No. FB-01356* on July 26, 2019 as an open and competitive solicitation. The bids were due on September 11, 2019. Three firms responded to the solicitation: Gillig, New Flyer and Nova Bus Co. (Nova). Nova submitted a No Bid proposal. The price breakdown per bus under each option as well as a comparison to the original prices under the Commonwealth of Virginia Contract are illustrated below.

Note that the County has had a commercial history with both of these firms. The County has previously purchased 120 CNG-powered buses from Gillig pursuant to Resolution No. R-1262-18 (Lynx Contract) and the County has also previously purchased 64 hybrid buses from New Flyer pursuant to Resolution No. R-564-15.

The County elected option 1 as the most cost efficient and delivery effective option and recommended New Flyer as the awarded firm. The difference between the total price of the Commonwealth of Virginia Contract (\$80,938,454) and FB-01356 (74,548,600) is \$6,389,854 in savings.

As mentioned above, this procurement will replace buses that have exceeded their useful life. DTPW has confirmed that fueling capabilities exist at County depots to accommodate all CNG buses being purchased. The fiscal impact for this purchase is \$74,548,600, covering 140 CNG buses that are scheduled for delivery to the County on August 31, 2020.

CNG Procurement History

On May 6, 2014, Resolution No. R-419-14 authorized the County Mayor to advertise a Request for Proposals (RFP), establishing a CNG Program. The resolution authorized the advertisement of two solicitations inviting qualified proposers to deliver CNG programs. The first advertisement concerned the Transit Department (currently the Department of Transportation and Public Works). The second related to the Internal Services Department (ISD), the former Public Works and Waste Management Department (currently the Department of Solid Waste Management), and

the Water and Sewer Department (WASD). The selected proposer for each RFP would be required to negotiate a Master Developer Agreement to design, build, finance, operate, and maintain CNG facilities and infrastructure. In the case of the Transit Department, the selected proposer would be required to convert the diesel bus fleet to CNG and build two CNG fueling facilities. Each RFP sought a single developer for implementation. The mayoral memorandum accompanying the resolution noted that fully implemented public-private partnerships would provide a positive fiscal impact for long-term fuel cost reductions and generate new revenue from CNG sales to private and public sector entities.

On December 4, 2018, through Resolution R-1258-18, the Board directed the County Mayor to exercise the option in the Master Developer Agreement to construct a third CNG Fueling Facility at the Northeast Bus Depot and procure additional CNG buses. On December 13, 2019, through Resolution R-1316-19, the Board directed the County Mayor to approve supplemental agreement 1, for Contract No. 00096, increasing the contract amount by \$47,587,277 for the development of the Northeast Bus Depot.

On July 15, 2019, an award for the purchase of up to 75, 40-foot battery-electric buses, and the installation of depot chargers for a total cost of \$72,176,322 came before the Transportation and Finance Committee. The procurement for battery-electric buses had originally been advertised On October 21, 2016, via a Request for Proposals. The item was removed by the administration at the Transportation and Finance Committee meeting. The item was ultimately approved by the BCC on October 3, 2019, through Resolution No. R-1041-19, awarding the contract to Proterra, Inc. for a five-year term. The subject contract included the installation of depot chargers at DTPW's three maintenance garages.

Accordingly, DTPW is pursuing two distinct energy types to power its bus fleet – CNG and electric.

Board-Approved CNG Buses Chronology

- On January 2017, the contract with Trillium LLC established the purchase of 300 CNG buses via Resolution No. R-35-17.
- On January 23, 2019, a purchase order through the Lynx contract for 120 CNG buses was approved via Resolution No. R-99-19.
- DTPW's current Board-approved CNG bus fleet totals 420.
- On January 22, 2020, a transportation grant agreement for eleven CNG Buses for a total project amount of \$6,000,000.
- With the approval of this item, DTPW's CNG bus fleet would total 560 CNG buses. The full delivery of the buses is anticipated by August 31, 2020.

APPLICABLE LEGISLATION/POLICY

Formal sealed bids shall be secured for all such contracts and purchases when the transaction involves more than the minimum amount established by the Board of County Commissioners by ordinance.

CIP196-DTPW18-DE, IN AN AMOUNT NOT TO EXCEED \$1,999,801.16, INCLUSIVE OF A CONTINGENCY ALLOWANCE OF \$99,933.06; AND AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO EXECUTE SAME AND TO EXERCISE THE RIGHTS CONTAINED THEREIN

ISSUE/REQUESTED ACTION

Whether the Board should approve a Professional Services Agreement (PSA) between the County and Kimley-Horn and Associates, Inc. for engineering services for the Underline, *Contract No. CIP196-DTPW18-DE* in an amount not to exceed \$1,999,801.16, for a term of five-years with two three-year options to renew.

PROCEDURAL HISTORY

Prime Sponsor: N/A

Department/Requester: Transportation and Public Works

This item has no procedural history.

ANALYSIS

The purpose of this item is to establish a PSA with County and Kimley-Horn and Associates, Inc. for engineering services for the Underline, a 10-mile multimodal corridor of repurposed space beneath the Metrorail intended to increase pedestrian and bicyclist safety and provide connectivity to public transportation. The PSA's award amount of up to \$1,999,801.16 includes a contingency allowance of \$99,933.06 (5.26%). The award is for a five-year term, with two, three-year options to renew. Funding for the \$1,999,801.16 contract will come from Florida Department of Transportation (FDOT) funds in the amount of \$1,499,850.87 and Road Impact Fees in the amount of \$499,950.29. The item is currently pending approval by the Citizen's Independent Transportation Trust (CITT).

The project consists of providing a Design Criteria Package (DCP) for the remaining seven segments of The Underline, extending from SW 19th Avenue to Dadeland Boulevard in Commission Districts 5 and 7, represented by Commissioners Eileen Higgins and Xavier L. Suarez respectively. Under the PSA, the consultant agrees to provide pre-design services to include topographic, tree, drainage and storm stewer surveys, civil engineering, construction cost services, specialty lighting consulting, value engineering coordination, and cost saving initiatives to assure the future design and construction of the seven segments of the Underline fall within the allocated budgets. The delineated tasks are as follows:

- Task 3 Cultural Assessment Services
- Task 4 Environmental Engineering Services
- Task 5 Site Ride-Through and Project Initiation

The solicitation was advertised on April 5, 2019, yielding four respondents. The proposals were received by the May 8, 2019 submittal deadline. After the First-Tier meeting, the Competitive Selection Committee decided to forgo Second-Tier proceedings and recommended that negotiations be conducted with the highest ranked firm, Kimley-Horn and Associates, Inc. The table below provides the ranking of the top firms and their total qualitative points.

The PSA indicates that compensation will either be in lump sum, or direct salaries subject to a multiplier, or a combination thereof. In the event that a multiplier of direct salary cost and fixed hourly rate is used, the fee for engineering services rendered by the consultants personnel, principals excluded, is to be computed based on the direct salary cost, for the time of said personnel engaged directly in the work, times a 3.2295 multiplier for office personnel and a 3.0073 multiplier for field personnel, as specified below.
