
Purpose

The purpose of this report is to provide an analysis on the historical and forecasted data of the People's Transportation Plan (PTP) collections, as well as the contributions made from the People's Transportation Plan and the General Fund Maintenance of Effort (MOE) to the Miami Dade Department of Transportation (MDT).

Historical data has been gathered from Miami Dade County's financial system of record (FAMIS and Data Warehouse), whereas forecasted data has been gathered from the FY 2019-20 PTP and Transit Pro-Forma Summary (July 2019 Edition) provided by the Office of Management and Budget (OMB).

People's Transportation Plan (PTP) Analysis

OCA's review indicates that the total collection of the PTP is as follows:




The detail of the total amount collected from FY 2003 to FY 2019 (as of August 31, 2019) is specified below:

According to the FY 2019-20 PTP and Transit Pro-Forma Summary (July 2019 Edition), the forecasted interest revenue is \$4 million over the next 40 years, with estimated annual earnings of \$100,000. The actual interest earned has fluctuated over the past 15 years with the highest being \$5.8 million and the lowest being \$137,000 as indicated on the graph below.

According to OMB, the decreased in interest revenue from FY 2010 to FY 2017 was due to the economic crisis where interest rates dropped nationwide.

In terms of funds transferred from PTP to MDT operation and maintenance, as of August 31, 2019, the MDT has received \$1.6 billion in proceeds for Transit related activities, including debt service. The projected total transfer over the next 40 years is \$2.4 Billion.

According to OMB, \$486 million was used for non-PTP operating expenses; this transfer also includes the Loan for Existing Services (\$119 million) which was paid back including interest.

County Wide General Fund Maintenance of Effort (MOE)

Our review indicates that the total County Wide General Fund-Maintenance of Effort to MDT from FY 2003 to FY 2019 (as of August 31, 2019) is \$2.5 Billion while the total projected contribution is \$26.3 Billion during the next 40 years.

According to directives provided by the Board of County Commissioners (BCC) in FY 2005, the required MOE amount was to increase by 3.5% annually.

However, the MOE support will increase more than 3.5% since the PTP will absorb the increased debt service requirements according to OMB.

The projected increase for the next four years is as follows:
