#### **Purpose**

At the request of District 5, represented by Commissioner Eileen Higgins, the Office of Commission Auditor (OCA) conducted research on the Tree Trust Fund (TTF) to provide financial information on the Tree Trust Fund (TTF) accounts, Sub-funds, and projects. OCA also assessed the operational factors associated with revenue generation and disbursements of funds related to the TTF to validate the balance of available funds.

#### Scope

In this initial report, OCA reports on the current account balances and historical revenues and expenditures of the TTF. OCA was also tasked with gathering information regarding committed funds that would impact the account balance.

#### **Methodology**

This report, prepared in collaboration with the Regulatory & Economic Resources Department (RER) as subject matter experts, is substantially less detailed in scope than an audit in accordance with the Generally Accepted Auditing Standards (GAAS). OCA plans and performs the review to obtain sufficient, appropriate evidence to provide a reasonable basis for our findings and conclusions based on our objectives; accordingly, OCA does not express an opinion on the data gathered by the subject matter experts.

To produce this report, OCA conducted qualitative analytical research on all related legislation and quantitative financial review of the accounts. Historical data has been gathered from Miami-Dade County's financial system of record (FAMIS Data Warehouse and INFORMS); this includes available funds, budget, revenues, and expenditures for the last five fiscal years. Legislative records were reviewed using the County's LEGISTAR system and the Municode Library for Miami-Dade County's Codes. OCA also reviewed information and documents prepared by RER and virtually met with the Department's staff to discuss OCA's observations related to the information gathered.

#### **Tree Trust Fund Overview**

#### **Fund Contributions**

Upon adopting Ordinance No. 89-9, the Tree Trust Fund was established to acquire, protect, and maintain Natural Forest Communities (NFC) in Miami-Dade County and plant trees in the public-owned property. Per *Section 24-39*, funds are deposited into the Tree Trust Fund in three ways<sup>1</sup>:

- 1. Collections resulting from environmental damages to tree and forest resources.
- 2. Grants and donations.<sup>2</sup>
- 3. Mitigation contributions received pursuant to conditions specified in tree removal or replacement permit.

The funds accounted for in the TTF consist of permitting, mitigation, and consent agreement activity related to tree removal or relocations.<sup>3</sup> A permit is required for any removal or relocation of trees within Miami-Dade County.<sup>4</sup> All tree removal and relocation within Miami-Dade County shall follow *Section 24-49* of the Miami - Dade County Code of Ordinance.<sup>5</sup> All applicants must pay a permit application fee and an initial inspection fee before the application is processed. Once the permit is issued, other fees include the final inspection fee, along with a per tree fee.<sup>6</sup>

In Section 24-49.7, the Code of Ordinance establishes that permits and mitigations may have special permit conditions for the applicant and require a performance bond (equivalent to 100% of the estimated cost of the permitted activity) to be placed in a separate asset holding trust fund until all requirements of the permits are fulfilled.<sup>7</sup>

If any portion of the mitigation work for the issued permit is incomplete, the permit applicant will receive a release of the bond amount equivalent to the work completed, and the remaining balance will be contributed to the TTF.<sup>8</sup> Special permit conditions for tree removal include the exact requirement to satisfy a canopy replacement, and the specific tree mitigation payment shall be placed in the TTF.<sup>9</sup> Staff verifies that all permit conditions and canopy replacement requirements are met before permit closure and/or bond release.<sup>10</sup> This information is entered into the department's PEN system and tracked by the project manager.<sup>11</sup>

#### **Fund Disbursements**

Disbursements from the TTF require approval by the Board of County Commissioners unless funds were received under a permit condition. <sup>12</sup> On an annual basis, Thirty-five percent (35%) of the previous fiscal years' contributions to the TTF shall be placed to a subaccount dedicated solely to planting trees on public property.

Table 1 contains the current TTF fund balance as of July 31, 2021, the committed amounts, <sup>15</sup> and the available balance as of July 29, 2021. Table 2 provides historical fund balances for all projects under the TTF.

#### **Tree Planting on Publicly Owned Property**

This account serves as the main account for revenues collected in accordance with the Code, such revenues are later distributed to fund expenditures of other approved accounts/projects. Table 3 details the historical revenues and expenditures for Tree Planting on Publicly Owned Property as of July 31, 2021.

According to the Department, the large increase in collections for FY 2017-18 was due to three (3) mitigation bond deposits for \$212,000. These mitigation bonds ensure that the permittee replaces the tree canopy that was approved to be removed by the permit. In all three cases, the permit required the canopy replacement to be completed by the permittee. RER's final inspection confirmed that the canopy was not replaced and the bond was pulled. Section 24-39(4)(c) of Miami-Dade County code of ordinance requires that contributions collected in lieu of replacement planting requirements be placed in the TTF. 19

The Office of the Commission Auditor's review of this Trust Fund confirmed that the account accumulated funds over the last five years from revenue generated but did not have any record of commitments from the department (RER) for the use of the funds. The current balance of \$4.2 million is not currently committed to any project and can be appropriated by Board approval in accordance with the Code, the status of the uncommitted funds was confirmed by RER.

#### **Neat Streets Miami**

According to OCA's research and meetings with the PROS Department staff as the subject matter experts, the Neat Streets Tree Program is funded primarily by receiving 35% of the prior year's contributions made to the TTF.<sup>20</sup> These funds are awarded to different municipalities and entities based on grant applications submitted by those entities. The use of funds is given to areas with 20% or less of tree canopyin a Census Tract in the fourth or fifth quintile distribution of Median Household Income.

In addition, the Neat Streets Program management applies to different grants and collaborates with private entities to fund and develop various programs such as the One Million Tree Miami Program and Keep Miami-Dade County Beautiful. These grant funds are directed to the Parks Foundation and kept in a separate account.




Figure 1 - Neat Streets Miami Project: Financials

The Figure 1 below provides historical revenues and expenditures for the Neat Streets Miami Project as of March 31, 2021. Table 4 details the historical revenues and expenditures for the Neat Streets Miami Project as of March 31, 2021. The total funds accumulated on this program is approximately \$893,000. According to the Department, \$537,000 of the funds are committed, and \$355,000 are available.<sup>21</sup>

## **Environmentally Endangered Lands Trust**

The Miami-Dade Code of Ordinances established the Environmentally Endangered Lands Acquisition Trust Fund (EEL Acquisition Trust Fund) and an Environmentally Endangered Lands Management Trust Fund (EEL Management Trust Fund). It provided the following guidance at the inception of the EEL Trust Funds.

- The EEL Acquisition Trust Fund receives funds from the following sources: (a) revenues collected by the Tax Collector pursuant to millage rates; (b) federal, state, or other governmental grants and private grants; (c) BCC allocations; and (d) interest generated from the aforementioned sources.
- The EEL Management Trust Fund receives funds from the following sources: (a) principal of \$10 million from revenues collected by the Tax Collector pursuant to millage rates; (b) federal, state, or other governmental grants and private grants; (c) BCC allocations; and (d) interest generated from the aforementioned sources.

#### **Pine Rockland Acquisition & Restoration**

Table 5 details the historical revenues and expenditures for the Pine Rockland Acquisition & Restoration Project as of March 31, 2021. For FY 2020-21, the table reflects a total collection of approximately \$863,000 in special assessments and impact fees, representing approximately 150% increase in the collections. According to the Department, a deposit of roughly \$494,000 was made into the fund since a developer in Miami-Dade County cleared a large former tree farm and could not replace over 1.2 million square feet of tree canopy within the development. Therefore, the developer contributed to the TTF since the replacement planting requirements could not be met.<sup>22</sup>

## **Miscellaneous Tree Planting**

Table 6 details the historical revenues and expenditure for the Miscellaneous Tree Planting Project as of March 31, 2021. For FY 2017-18, the data reflects an overall decrease of approximately \$83,000 attributed to \$265,833 being allocated to project TTF004 (Holiday Hammock) according to BCC approved disbursement per Resolution R-55-14.<sup>23</sup>

#### Adopt-A-Tree Program

The Adopt-A-Tree Program (AAT) was implemented to help restore tree canopy throughout Miami- Dade County stemming from the citrus cancer eradication program, which resulted in a loss of approximately 545,000 citrus trees, over 80% of which were from residential properties. This program was initially funded through a contractual service agreement with the Florida Department of Agriculture and Consumer Services (FDACS) for \$6 million. Since the FDACS grant funding was exhausted in FY 2009-10, the program is currently funded through donations and RER operating funds. Adopt-A-TreeProgram events are typically held annually at three different locations in northern, southern, and central parts of Miami-Dade County, providing residential homeowners of single-family homes and duplexes with two free trees every year. Since its inception in 2001, approximately 214,000 trees have been adopted through FY 2019-20. Table 7 provides historical revenues and expenditures for the Adopt-A-Tree Program

More than 50% of the expenditures are related to plants, postage, mail, and printing services from FY 2016-17 through FY 2019-20. Personnel charges related to AAT are funded by the Department of Regulatory and Economic Resources (RER) operating revenues. RER is currently working on a Chapter 24 Code change to allow the TTF to cover the purchase of trees and administering the AAT, an estimated \$300,000 based on FY 2018-19 actuals.<sup>28</sup>

#### **Street Tree Replacement Project**

The Street Tree Replacement Fund was established to accept funds collected from insurance companies and other entities to replace trees, shrubs, and other landscaping materials in County roads rights-of-way. Such funds will only be used to replace trees and other landscaping materials damaged or destroyed in the County's Road rights-of-way.<sup>29</sup> This project is managed by PROS Right-of-Way Assets and Aesthetics Management Division (RAAM) and is not funded by the TTF.




Figure 2 - Street Tree Replacement Project: Financials

Figure 2 provides historical revenues and expenditures for the Street Tree Replacement Project as of March 31, 2021. Table 8 details the historical revenues and expenditures for the Street Tree Replacement Project as of March 31, 2021. For the FY 2019-20, the figure reflects expenditures of approximately \$186,000, which are attributed to an approved expenditure for replacing trees, shrubs, and other landscaping materials in Districts 1, 2, and 4.30 The total funds accumulated on this program are approximately \$168,000 and are available as of March 31, 2021.31

#### **Conclusion**

OCA intends to continue its collaborative work on these Trust Funds with the Department (RER) through an audit engagement to assess the effectiveness of internal controls. This future engagement will provide a sufficient period to document and review pertinent internal policies, approvals levels, and procedures related to the funds' operational activities and financial management.

This report will serve as a summary document that provides an overview of the financial state of the selected funds. Although there were inherent limitations in the functionality of the prior Financial System of Record (FAMIS) for managing the activities related to individual projects and commitments, RER was able to provide OCA with useful information compiled by RER staff used for tracking and managing projects. The information provided was sufficient to determine that the current balance of \$4.2 million for Project 618267TTF008 (Tree Planting On Publicly Owned Property) was uncommitted and available as of July 31, 2021. OCA recommends that a plan for the appropriation of the available funds and any change to the annual contribution percentage should be conducted for the future goals related to the intended use of the Trust Fund
