

BOARD DISCUSSION – NON-AGENDA

Re: Trade Examinations

Board member Charles Goins addressed the Board on the trade examinations, specifically the plumbing exam, stating industry would like to see a 100 question plumbing examination and closed book. Phil Trucks from the Plumbers Local Union No. 519 addressed the Board on this issue stating industry is concerned with putting forth qualified quality plumbers and feel strongly that the plumbing examination needs to be modified. It was mentioned that as it is, the percentage of passing is low. Mr. Goins indicated that the current 40 question exam lessens the odds of passing. Additionally, Mr. Trucks stated the Union's desire for the return of a plumbing practical examination which was held in the past. Michael Goolsby stated as to the practical examination that the sentiment has been that there may be a liability issue with creating their own test. Further, Michael Goolsby informed the Board that the exam company is under contract and can look at making changes to the specifications when the contract expires. Mr. Goolsby stated that this can be done internally and does not need to go before the Board of County Commissioners. The Chairman Bustamante added the Board has the authority and discretion as to the contents of the exams. Art Fernandez suggested perhaps members need to review the exams and see if an upgrade is needed. Michael Affronte stated the examination company does not give you individual exams for review but only let you review their pool of questions. Oriol T. Haage, Electrical Code Compliance Specialist,

informed the Board that a review of exams had been conducted and in the electrical trade's pool of 500 questions, some changes were made to the electrical journeyman examination, otherwise overall electrical members found the exam questions to be fair. After some discussion, the Board asked that the examination company administrator, Jay Bowermeister, appear before them at the next meeting to further address this issue.

<u>Subject</u>: Illegally Obtained Contractor Licenses Evidentiary Formal Hearings

The Chairman, Nestor Bustamante, addressed the issue of continuance request from Respondent's attorney, some of which have made multiple/continuous request for postponement of scheduled hearings. In this regard, it was his recommendation that on a timely request for continuance by respondent's attorney, staff may administratively grant a first request. However, any subsequent request for continuance by respondent's attorney should be referred to the Board for consideration. Additionally, Mr. Bustamante asked staff to schedule all cases for an evidentiary hearing regardless if respondent is requesting a change of plea. They may do so upon the onset of the hearing. BOARD DISCUSSION

Jay Bowermeister of Gainesville Independent Testing Services, LLC ("GITS"), who provides the construction trades examination for Miami-Dade County, had been asked to appear before the Board to discuss the examinations. Several Board members, as well as the industry, had expressed their concern with an overall improvement of the trades examinations. Additionally, the plumbing industry has asked that a practical plumbing examination be reinstated as existed in the past. Mr. Bowermeister stated that he has submitted in the next contract renewal specifications to lengthen the examination to 100 questions for the master exam and 75 questions for the journeyman exam. Additionally, provide a split exam wherein a portion of the exam is open and closed book. Further, Mr. Bowermeister stated they are working on the capability for a future plumbing practical exam. Michael Goolsby informed the Board that the Board of County Commissioners is responsible for approving the budgetary expenditure, however, the department decides on the contents and mechanics of the examination. Mr. Bowermeister concluded his report to the Board by stating that, if the contract renewal modifications submitted is approved, the Board and the industry will get what they want in terms of seeking an examination which provides for fair results and quality tradesman. Mr. Bowermeister encouraged the Board members to actively participate in their twice a year workshop to review examination questions. In addition, Mr. Bowermeister stated he would see to it personally that they receive their invitation.

He commented that, while he is not in a position to make an independent evaluation, he appreciated the Board hearing this case and listening to the circumstances which have led to Mr. Wilson's unfortunate situation. Mr. Brown stated that he agreed with Mr. Wilson's attempt to get his license reinstated in order to have the opportunity to make things right. Additionally, he stated Mr. Wilson serves as a role model in the community as a minority Contractor with the ability to provide jobs for others keeping them from criminal activity.

Mr. Wilson addressed the Board explaining his situation with his state registration. He stated that once he had complied with a Board Order which resulted from a formal hearing going back to the Hurricane Andrew wherein mistakenly they hired out of town help, he thought that automatically his registration would have been reinstated. But it was not. When it was discovered some time later, the department issued a dummy number so as to help with closing out job permits until the re-registration application process could be completed by Mr. Wilson. That process ran into some problems which resulted in the recent formal hearing. Mr. Wilson informed the Board that he has since been issued a state registration but fears it will be withdrawn due to the revokation of his license. In this regard, Mr. Wilson is asking the Board for a reprieve of that Board Order so as to be able to satisfy the homeowners involved and move on.

Additionally, Mr. Wilson addressed the Board in terms of the illegally licensed contractor hearings indicating that the Board should remove themselves from hearing these cases because he believes it to be a conflict for the Board whose staff was involved in the issuance of these illegal licenses.

The Chairman informed Mr. Wilson that the Building Code Compliance staff is not employed by the Board and, therefore, he did not see the conflict nor felt that legally the Board is required to remove themselves. As to revise, stay or modify a Board Order issued by the "A"
