1. Shingles shall be labeled with the Miami-Dade Seal as seen below, or the wording “Miami-Dade County Product Control Approved”.

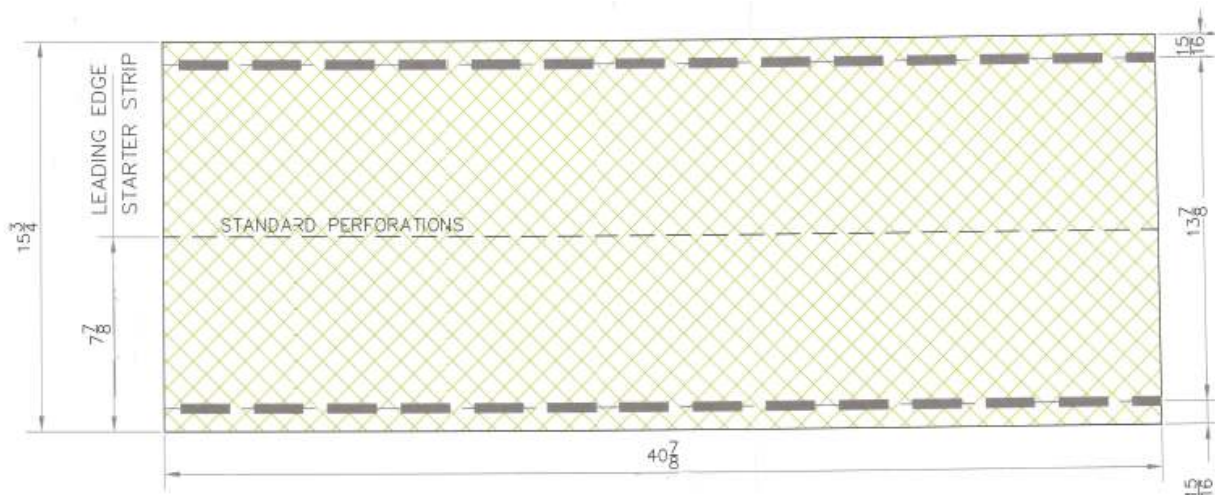
