INSTALLATION:

- 1. CLAD-GARD MA Roofing Underlayment and its components shall be installed in strict compliance with applicable Building Code.
- 2. CLAD-GARD MA Roofing Underlayment shall be installed with a minimum 4-inch head lap in a shingle layer fashion and a 6" end lap where required. Fastener spacing shall be a maximum of 4" o.c. on the head and end laps and 12" o.c. vertically and horizontally in the field of the membrane in compliance with Florida Building Code 1518.2.
- **3.** CLAD-GARD MA Roofing Underlayment may be used with Asphaltic shingles, Wood shakes and shingles, Non-structural metal roofing, and quarry slate.
- **4.** CLAD-GARD MA Roofing Underlayment shall not be used as roof tile underlayment or anchor sheet within a roof tile underlayment system.
- **5.** For fire classifications of specific roof assemblies using CLAD-GARD MA Roofing Underlayment refer to a current Approved Roofing Materials Directory for fire ratings of this product.

- **4.** CLAD-GARD MA Roofing Underlayment shall not be left exposed as a temporary roof for longer than 30 days of application. Firestone Building Products Company, LLC., reserves the right to revise or alter product exposure times; not to exceed the preceding maximum time limitations.
- **5.** CLAD-GARD MA Roofing Underlayment can be used in any prepared roof assemblies were an ASTM D 226 Type I & II is required with the exception of Roof Tile Systems.
- 6. CLAD-GARD MA Roofing Underlayment may be used with any approved roof covering Notice of Acceptance listing CLAD-GARD MA Roofing Underlayment as a component part of an assembly in the Notice of Acceptance. If CLAD-GARD MA Roofing Underlayment is not listed, a request may be made to the Authority Having Jurisdiction (AHJ) or the Miami-Dade County Product Control Department for approval provided that appropriate documentation is provided to detail compatibility of the products, wind uplift resistance, and fire testing results.
- 7. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code
