Deck Description: New Construction ¹⁹/₃₂" or greater plywood or wood plank.

Slope Range: 2": 12" or greater

Deck Attachment: In accordance with applicable Building Code, but in no case shall it be less than 0.113 x 2-

3/8" ring shank nails spaced 6" o.c. along perimeter and intermediate supports.

Underlayment: Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4"

side-lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant 1-5/8" tintabs and 1 1/4" ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in

the field of the roll. Or, any approved underlayment having a current NOA.

Fire Barrier Board: Any approved fire barrier having a current NOA. Refer to a current fire directory listing for

fire ratings of this roofing system assembly as well as the location of the fire barrier within

the assembly. See Limitation #1.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133

and with Florida Metal Products' current published installation instructions.

Metal Panels and Accessories:

Install the "UC-3 Copper Panels" and accessories in compliance with Florida Metal Products' current, published installation instructions and details. Flashing, penetrations, valley construction and other details shall be constructed in compliance with the minimum

requirements provided in Roofing Application Standard RAS 133.

Panels should be attached with UC-3 Expansion Clips, installed with #10-12 x 1-1/2" PH fasteners (two (2) per clip) at a maximum spacing listed below in **Table A**. Standing seams

shall be mechanically seamed to a full 1800 degree seam, (double lock).

All panels shall be permanently labeled with the manufacturer's name and/or logo, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




