





GLAZING DETAIL 1-1/16" OVERALL INSUL. LAM. GLASS




- STEP 1 DETERMINE DESIGN WIND PRESSURE REQUIREMENTS BASED ON WIND VELOCITY, BLDG. HEIGHT, WIND ZONE USING APPLICABLE ASCE 7 STANDARD.
- STEP 2 FOR FIXED WINDOW CAPACITY SEE SHEET 1.
- STEP 3 CHECK MULLION DESIGN LOAD CAPACITY FOR GIVEN WIDTH AND HEIGHT USING CHART ABOVE.
 THE CAPACITY SHOULD EXCEED THE DESIGN LOAD.
- STEP 4 USING CHART ABOVE SELECT ANCHOR OPTION WITH DESIGN LOAD CAPACITY MORE THAN DESIGN LOAD SPECIFIED IN STEP 1 ABOVE.
- STEP 5 THE LOWEST VALUE RESULTING FROM STEPS 2, 3 AND 4 THAT EXCEED THE DESIGN WIND PRESSURES DETERMINED THRU STEP 1 SHALL APPLY TO ENTIRE SYSTEM.
