Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133

and with the current published installation instructions and details in Sunlast Metals Inc.'s

Roofing Installation Manual.

Install the "Jax Beach Series 1.5" Clipless Snaplock x 24ga Steel Panel 15" or 19" wide panel" including flashing penetrations, valleys, end laps and accessories in compliance Sunlast Metals Inc.'s current, published installation instructions and in compliance with the minimum requirements detailed in Roofing Application Standard RAS 133.

Panels shall be installed along the clipless seam with corrosion resistant #10 pancake head screws of sufficient length to penetrate through the sheathing a minimum of $^3/_{16}$ " at a distance listed below in **Table A**. A continuous bead of Bostik 70-05A adhesive shall be applied on each side of the male rib before snapping the female end of the adjacent panel in

place. See Details herein.

- 3. Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133.


5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.




