SYSTEM A-1: Zee-Lock Aluminum Roof Panel

Deck Type: Wood, Non-insulated

Deck Description: New Construction or Re-roof 15/32" or greater plywood or wood plank.

Slope Range: 2": 12" or greater **Maximum Uplift See Table A Below**

Pressure:

Deck Attachment: Deck shall be attached in accordance with applicable Building Code, but in no

case shall it be less than 8d x 2-1/2" galvanized ring shank roofing nails spaced 6" o.c. at roof perimeter and field. In reroofing, where the deck is less than 19/32" thick (Minimum 15/32") the above attachment method must be in addition to

existing attachment.

Underlayment: Minimum underlayment shall be an ASTM D 226 Type II installed with a

minimum 4" side-lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant 32-gauge tin-caps and 12 gauge 1 1/4" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll.

Or, any approved underlayment having a current NOA.

Fire Barrier: Any approved fire barrier having a current NOA. Refer to a current fire directory

listing for fire ratings of this roofing system assembly as well as the location of

the fire barrier within the assembly. See Limitation # 1

Valleys: Valley construction shall be in compliance with Roofing Application Standard

RAS 133 and with manufacturer's current published installation instructions.

Metal Panels and Accessories:

Install the "Zee-Lock Steel Roof Panel" and accessories in compliance with Berridge Manufacturing Company's current published installation instructions and details. Flashing, penetrations, valley construction and other details shall be constructed in compliance with the minimum requirements provided in Roofing Application Standards RAS 133.

- 1. "Zee-Lock" Roof Panels shall be attached to the plywood substrate along its male rib using the approved clips (floating two-piece). Each clip shall be attached to the substrate with two (2) corrosion resistant #14-10 HWH screws of sufficient length to penetrate through the sheathing a minimum of 3/16" at a spacing as listed in **Table A** below.
 - Attach adjacent panel by placing the female rib over the male rib and clip.
- 2. Standing seams shall be mechanically seamed to a full 180 degrees seam (double lock).

or more spans without end-laps.

Slope Range: Maximum Uplift 2": 12" or greater **See Table A Below**

Pressure:

Deck Attachment: Minimum 22 gage steel deck shall be secured 12" o.c. to structural supports

spaced a maximum of 5 ft o.c. with one (2) $\frac{1}{4}$ "-14 x 1-1/4" long Hex Head screws fastened at the bottom of each flute (6" o.c.). Deck sidelaps shall be fastened 12"

o.c. with #12-14 x 1" Hex Head stitch screws.

Insulation: (Requires a bearing plate (min.24ga.) for clip attachment) ³/₄" minimum up to a 6"

maximum thickness of an approved rigid board insulation with current NOA having a minimum 20psi compressive strength fastened with approved fasteners and plates. Fastening density shall be in compliance with applicable Building

Code and Roofing Application Standard RAS 117.

Underlayment: Minimum underlayment shall be an ASTM D 226 Type II installed with a

minimum 4" sidelaps and 6" end-laps. Underlayment shall be fastened with corrosion resistant fasteners spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll. Or, any Miami-Dade County Product Control

Approved underlayment having a current NOA.

Fire Barrier: Any approved fire barrier having a current NOA. Refer to a current fire directory

listing for fire ratings of this roofing system assembly as well as the location of

the fire barrier within the assembly. See Limitation # 1

Valleys: Valley construction shall be in compliance with Roofing Application Standard

RAS 133 and with manufacturer's current published installation instructions.

Metal Panels and Accessories:

Install the "Zee-Lock Steel Roof Panel" and accessories in compliance with Berridge Manufacturing Company's current published installation instructions and details. Flashing, penetrations, valley construction and other details shall be constructed in compliance with the minimum requirements provided in Roofing

Application Standards RAS 133.

1. "Zee-Lock" Roof Panels shall be attached to the substrate along its male rib using the approved clips (floating two-piece). Each clip shall be attached to the substrate with two (2) corrosion resistant #14-13 low profile screws of sufficient length to penetrate the steel deck a minimum of 3/16" at a spacing as listed in **Table B** below.

Attach adjacent panel by placing the female rib over the male rib and clip.

- 2. Standing seams shall be mechanically seamed to a full 180 degree seam (double lock).
- 3. All clips are to be installed over a min. 24ga. Bearing Plate provided by Berridge, Inc.

- 2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners).
- 3. Panels may be roll formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133.
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, city, state, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.










ZEE-LOCK PANEL PROFILE

Floating Lower Section


Berridge Two-Piece Floating Zee-Clip
