### 1. SCOPE

This approves a roofing system using the **Classic “S” Mission Tile** manufactured in **Corona, CA..**, as described in Section 2 of this Notice of Acceptance. For locations where the pressure requirements, as determined by applicable Building Code does not exceed the design pressure values obtained by calculations in compliance with RAS 127 using the values listed in section 4 herein. The attachment calculations shall be done as a moment based system.

### 3. LIMITATIONS

- 3.1 Fire classification is not part of this acceptance.
- 3.2 For mortar or adhesive set tile applications, a static field uplift test shall be performed in accordance with TAS 106.
- 3.3 Applicant shall retain the services of a Miami-Dade County Certified Laboratory to perform quarterly test in accordance with TAS 112, appendix 'A'. Such testing shall be submitted to the Miami-Dade Product Control office for review.
- 3.4 30/90 hot mopped underlayment applications may be installed perpendicular to the roof slope unless stated otherwise by the underlayment material manufacturers published literature.
- 3.5 This acceptance is for wood deck applications. Minimum deck requirements shall be in compliance with applicable building code.
- 3.6 All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.

### 4. INSTALLATION

- 4.1 **Classic "S" Mission Tile** and its components shall be installed in strict compliance with Roofing Application Standard RAS 120 with the following exceptions:
  - Only underlayment system allowed for this system shall be as follows:
    - o One layer of ASTM D 226 Type II #30 mechanically attached to the wood deck with approved fasteners spaced in a 12" grid staggered in two rows in the field, and 6" on center at the laps. Extend anchor/base sheet a minimum of 4" up vertical surfaces. Anchor/base sheet end laps shall be a minimum of 6" and head laps shall be a minimum of 4". Over installed anchor/base, apply a minimum of one layer of Polyglass TU Plus as per current NOA.

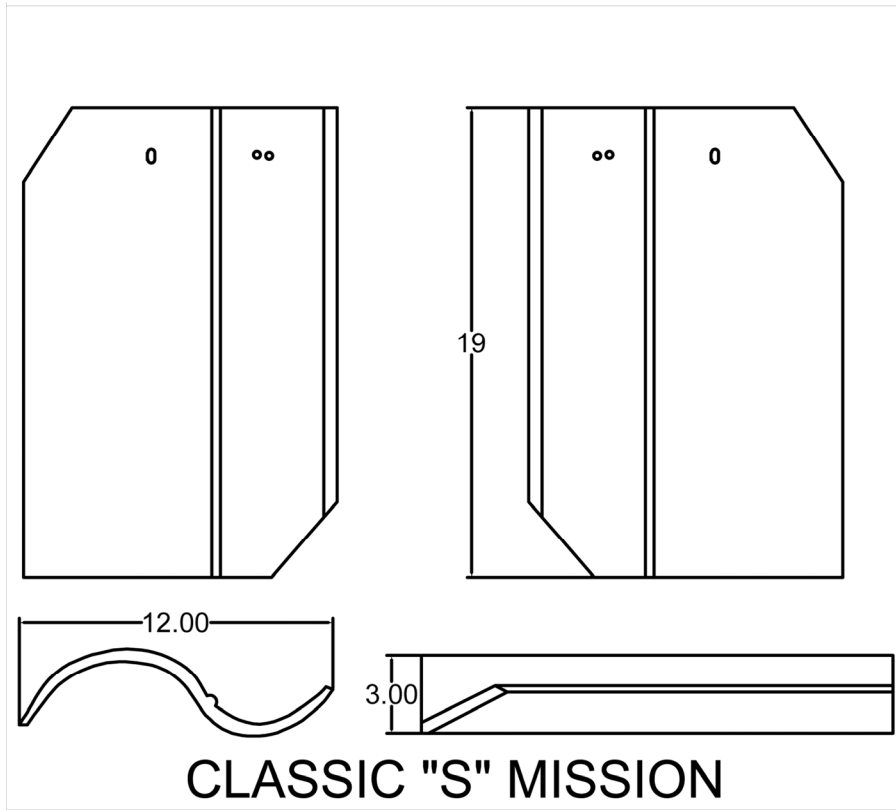

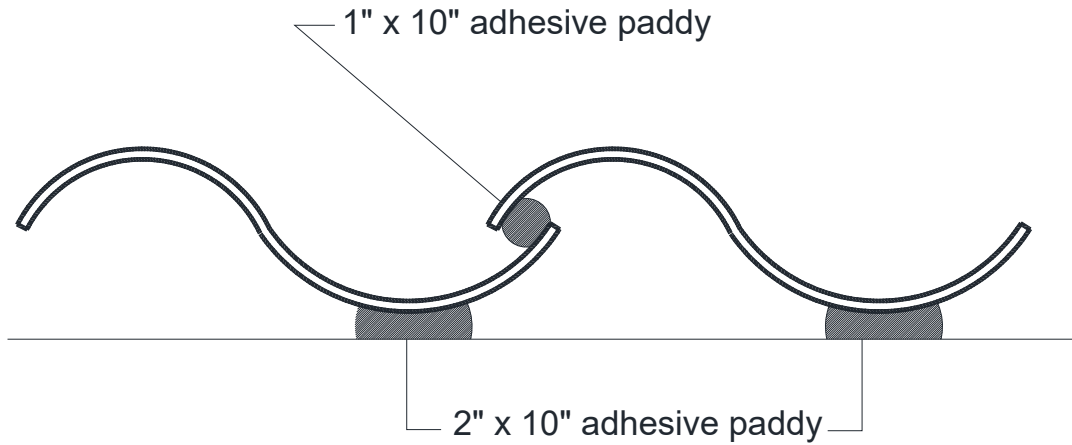
