APPROVED ASSEMBLIES:

- Deck Type 1:** Wood
- Deck Description:** $1\frac{9}{32}$ " or greater plywood or wood plank
- System Type E:** Anchor sheet mechanically fastened.

All General and System limitations apply.

Anchor Sheet: One or more plies of ASTM D 266 Type II or ASTM D 2626 with a minimum 4" side lap and a 6" end lap mechanically fastened to deck with approved nails and tin caps 6" o.c. at the laps and two staggered rows 12" o.c. the field of the roll.

Membrane: Cut Grace Ice & Water Shield® membrane into 10 to 15 feet lengths and reroll. Peel back 1 to 2 feet length of release paper, align membrane on the lower edge of the roof and place the 'first' 1 to 2 feet length of membrane. Pull the release paper under the membrane and continue to peel it from the membrane, while pressing the membrane in place. Roll lower edges firmly with a wallpaper or other type hand roller. Always begin application at low point of the roof, applying membrane in shingle fashion to shed water.

Grace Ice & Water Shield® shall be overlapped to shed water a minimum of 3½". End laps shall be a minimum of 6". Membrane shall not be applied to the exposed face of the roof edge.

Valleys: For valley application, peel the release paper, center the sheet over the valley or ridge, drape and press it in place, working from the center of the valley or ridge outward in each direction. Apply membrane starting at the low point and work upwards. Valley assemblies require double application.

Eave Termination: Metal drip of eave edges shall be installed over the primary membrane.


Surfacing: Any Approved Roof Assemblies where this product or an ASTM D1970 underlayment is specified or required.

WOOD DECK SYSTEM LIMITATIONS:

1. Joints in plywood or wood planks shall not be greater than $\frac{1}{8}$ of an inch wide.
2. All wood decks shall be fastened in accordance with applicable building code, and all existing fasteners shall be resealed to avoid any protruding fastener heads.
3. Miami-Dade Approved Adhesive shall be applied at all angles greater than 60°, or where unlike materials join. Miami-Dade Approved Adhesive shall be applied in compliance with manufacturer's published specifications and as specified in the NOA approval.



GENERAL LIMITATIONS:

1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire ratings of this product.
 2. Grace Ice & Water Shield® shall not be left exposed to weather for longer than 30days.
 3. All bonding surfaces shall be clean, dry and free from sharp or uneven edges.
 4. Primer is required on all concrete and masonry surfaces.
 5. All work shall be performed by a Dade County licensed roofing contractor. Contractor shall be familiar with the details and specifications published by the manufacturer.
 6. Minimum deck requirements shall be in compliance with applicable building code.
 7. Grace Ice & Water Shield® shall not be applied over an existing roof membrane as a recover system but may be applied over a roofing Base/Anchor sheet underlayment.
 8. Grace Ice & Water Shield® may be used with any approved roof covering Notice of Acceptance listing Grace Ice & Water Shield® as a component part of an assembly in the Notice of Acceptance. If Grace Ice & Water Shield® is not listed, a request may be made to the Authority Having Jurisdiction (AHJ) or the Miami-Dade County Product Control Department for approval provided that appropriate documentation is provided to detail compatibility of the products, wind uplift resistance, and fire testing results.
 9. All nails in the deck shall be carefully checked for protruding heads. Re-fasten any loose decking panels. Sweep the deck thoroughly to remove any dust and debris prior to application.
 10. Grace Ice & Water Shield® may be used in Asphaltic shingles, wood shakes and shingles, quarry slate roof assemblies and metal roof assemblies. Grace Ice & Water Shield® shall not be used as roof tile underlayment.
 11. When applying the membrane in the valley, start at the low point and work to the high point, rolling the membrane from the center outward in both directions.
 12. Roll or broom the entire membrane surface so as to have 100% contact with the surface, giving special attention to overlap areas.
 13. Flash vent pipes, stacks, chimneys and penetrations in compliance with Roof Assembly current Product Control Notice of Acceptance and applicable Building Code.
 14. All membranes or packaging shall bear the imprint or identifiable marking of the manufacturer's name or logo and the following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.
- A black oval seal with the text "MIAMI-DADE COUNTY" in white above "APPROVED" in white.
15. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 16G20-3 of the Florida Administrative Code.
