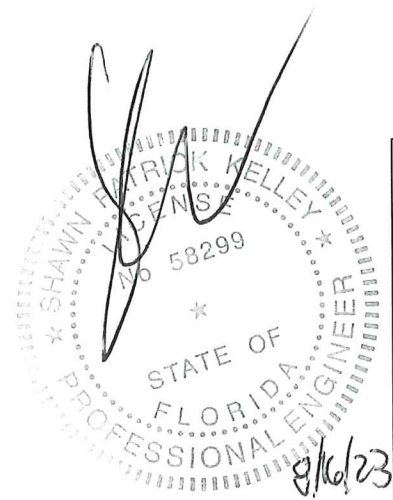

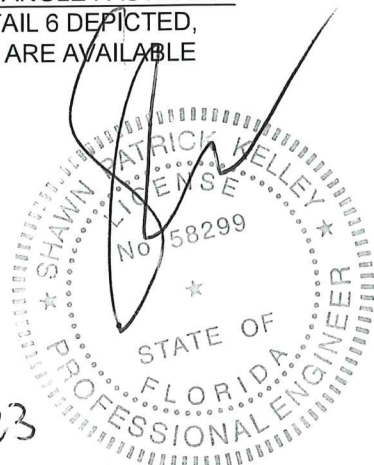






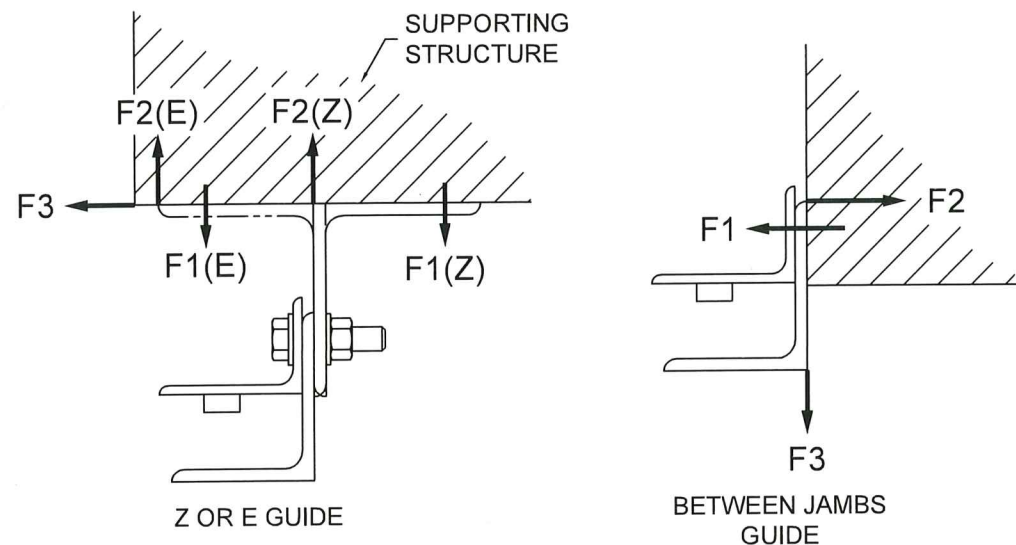
⑫ BRACKET MOUNTING / TOP WALL ANGLE FASTENING
