
1. Ridge Cap Shingles shall be labeled with the Miami-Dade Seal as seen below, or the wording "Miami-Dade County Product Control Approved".





**SHADOW RIDGE**



### SHANGLE RIDGE


1/4" wide bead of adhesive, 7" long,  
3/4"-1" from side edge of cap shingle




Nailing pattern all applications - two nails per shingle.
