### 1. SCOPE

This approves a roofing system using **ArteZanos® Arguey ‘S’ Clay Roof Tile**, as manufactured by **Mundo Negocios Export SAS** in **Cucuta, Colombia** and distributed by **ArteZanos®, Inc.** as described in Section 2 of this Notice of Acceptance. For the locations where the pressure requirements, as determined by applicable Building Code, does not exceed the values listed in section 4 herein. The attachment calculations shall be done as a moment based system.

### 3. LIMITATIONS

- 3.1 Fire classification is not part of this acceptance.
- 3.2 For mortar or adhesive set tile applications, a static field uplift test shall be performed in accordance with TAS 106.
- 3.3 Applicant shall retain the services of a Miami-Dade County Certified Laboratory to perform quarterly test in accordance with TAS 112, appendix 'A'. Such testing shall be submitted to the Building Code Compliance Office for review.
- 3.4 Minimum underlayment shall be in compliance with the applicable Roofing Applications Standards listed section 4.1 herein.
- 3.5 30/90 hot mopped underlayment applications may be installed perpendicular to the roof slope unless stated otherwise by the underlayment material manufacturers published literature.
- 3.6 This acceptance is for wood deck applications. Minimum deck requirements shall be in compliance with applicable building code.

- Arguey 'S' Clay Roof Tile and its components shall be installed in strict compliance with Roofing Application Standard RAS 120.

**System A(2):**

1. Arguey ‘S’ Clay Roof Tile and its components shall be installed in strict compliance as noted below

**Deck Attachment:** In accordance with applicable Building Code, but in no case shall it be less than 8d annular ring shank nails spaced 6” o.c. In reroofing, where the deck is less than <sup>19</sup>/<sub>32</sub>” thick (Minimum <sup>15</sup>/<sub>32</sub>”). The above attachment method must be in addition to existing attachment.

**Underlayment:** One layer of Sharkskin Ultra® mechanically fastened to the deck with approved roofing nails and tin caps spaced 6” o.c. at the 4” horizontal overlap and 10” o.c. in a grid pattern having three equally spaced, staggered rows in the field of the sheet followed by one layer of Sharkskin Ultra SA®.

Sharkskin Ultra SA® shall be applied with a minimum 2” horizontal end lap and minimum 6” vertical overlaps. Back nail to deck with approved annular ring shank nails and tin caps at a maximum of 12” o.c. at the side laps and 6” o.c. at the end laps.

**Valleys, Rakes, Ridges, Eaves, Penetrations:** Shall be constructed in compliance with Roofing Application Standard RAS 120 and with ArteZanos®, Inc.’s published installation instructions.

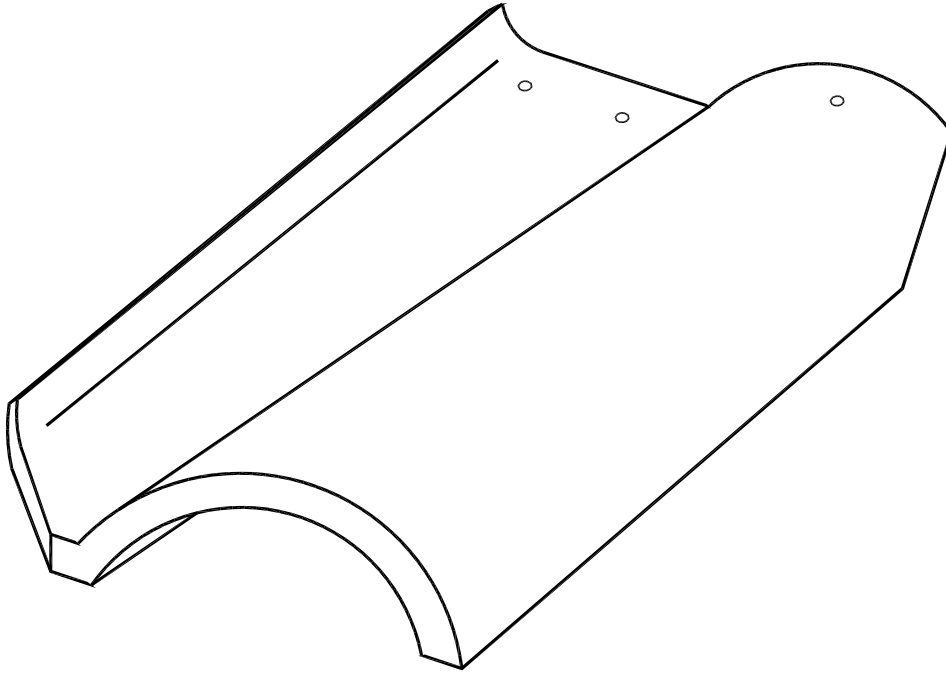

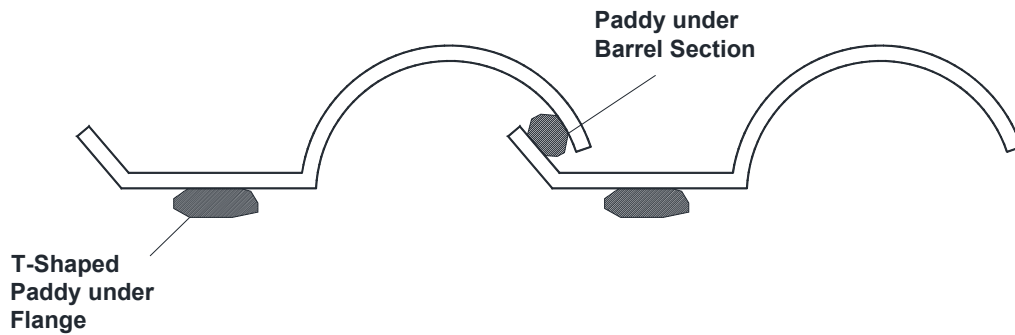
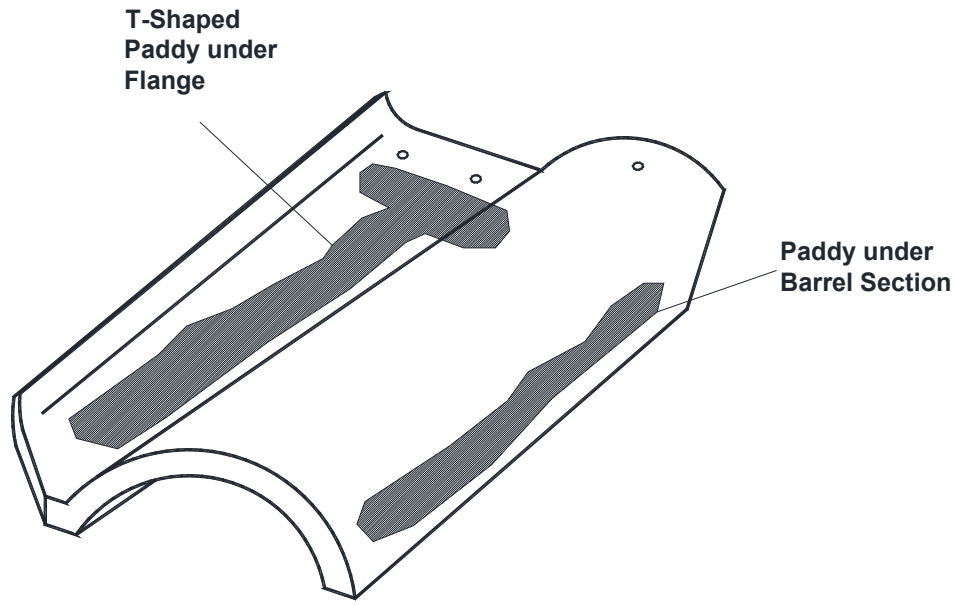
