#### APPROVED APPLICATIONS

Tradename: Unfiltered Rolled Ridge Vent and Filtered Rolled Ridge Vent
System Type: Mechanical attachment of ridge vent over asphalt shingle roof systems only.

Cutout: Cut shall be 1-1/2" wide cut slot at the ridge, and 6" shorter at each end than the total length of

the ridge vent to be installed.

**Installation:** Install vent using 12ga. ring shank nails long enough to penetrate the decking min. 3/16 into the

decking, placed through the ridge shingles- 1" from ends of the ridge shingles and 5 7/8" up from

exposed edge.

Ridge Shingle: Install pre-manufactured or field-cut ridge shingles over the ridge vent in compliance with the

shingle manufacturer's Notice of Acceptance (NOA) and the installation instructions. Ring shank nails shall be corrosion resistant and long enough to penetrate through the wood deck a

minimum of 3/16".

**Net Free Area:** Refer to manufacturers published literature.

#### **LIMITATIONS:**

1. Refer to applicable Building Codes for required ventilation.

- 2. This acceptance is for installations on asphalt shingle roof systems only.
- 3. CertainTeed LLC, Unfiltered Rolled Ridge Vent and Filtered Rolled Ridge Vent shall not be installed on roof mean heights greater than 33 feet.
- 4. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- 5. All approved products listed herein shall be labeled and shall bear the imprint or identifiable marking of the manufacturer's name or logo and following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.








### **BOTTOM VIEW**






