**System Type A:** Mechanical attachment of ridge vent on asphaltic shingle roof systems (12"

installation)

**Slot:** Truss Construction: Cut a 1" slot on each side of the ridge starting a minimum of 12"

from the rake edge of the roof.

Ridge Pole Construction: Cut a 1" slot on each side of the ridge pole starting a

minimum of 12" form the rake edge of roof.

**Installation:** Using a chalk line, mark 1" on both sides of ridge (1" beyond ridge pole). Cut slot at a

depth to cut through the decking only. Seal the edge of the hole with approved roofing cement. Center ridge vent over the opening, ensuring that roof vent support pegs sit flat

on the roof.

Using the nail lines provided, nail vent unto deck using 0.120" diameter corrosion resistant annular ring shank approved roofing nails of sufficient length to penetrate through the thickness of sheathing or wood plank a minimum of 3/16" or penetrate into a 1" or greater thickness of lumber a minimum of 1", located one at each corner and 6" on center at manufacturer's pre-marked location. Install vent starting from outer edge moving inward. Ensure that each piece of the roof vent is joined together using the

male/female connectors.

Cut final piece to length so that it is flush with the edge of roof. Ensure that self-closed

end cap faces out to prevent water infiltration.

**Ridge Shingle:** Using nail lines provided on top of vent, install the cap shingles directly to the vent, in

compliance with the shingle manufacturer's Notice of Acceptance (NOA) and

installation instructions, using roofing nails of sufficient length to penetrate through the sheathing a minimum of  $^{3}/_{16}$ " or at least 1" into wood plank decking thicker than 1".

**Ventilation Calculations:** Refer to manufacturer's published literature.

System Type B: Mechanical attachment of ridge vent on asphaltic shingle roof systems (9" installation)

Slot: Truss Construction: Cut a 1" slot on each side of the ridge starting a minimum of 12"

from the rake edge of the roof.

Ridge Pole Construction: Cut a 1" slot on each side of the ridge pole starting a

minimum of 12" form the rake edge of roof.

**Installation:** On the underside of ridge vent, use utility knife and score the length of the roof vent in

the groove opposite of the cut/break line, for 9" application score both grooves. Once the underside has been scored, bend external baffle at grooves and remove both baffles. Overlap the removed external baffles onto the body of roof vent by inserting the 12"

nail support into the 9" receiving nail hole.

Using a chalk line, mark 1" on both sides of ridge (1" beyond ridge pole). Cut slot at a depth to cut through the decking only. Seal the edge of the hole with approved roofing cement. Center ridge vent over the opening, ensuring that roof vent support pegs sit flat

on the roof.

Using the nail lines provided, nail vent unto deck using 0.120" diameter corrosion resistant annular ring shank approved roofing nails of sufficient length to penetrate through the thickness of sheathing or wood plank a minimum of 3/16" or penetrate into a 1" or greater thickness of lumber a minimum of 1", located one at each corner and 6" on center at manufacturer's pre-marked location. Install one side of the roof vent, starting from the outer edge and moving inward. Bend the roof vent over the ridge and install the other side. Caulk gaps with approved roofing cement where the external baffle meets shingles and between low areas of shingle and external baffle. Do not plug weep holes. Ensure that each piece of the roof vent is joined together using the male/female connectors.

Cut final piece to length so that it is flush with the edge of roof. Ensure that self-closed

end cap faces out to prevent water infiltration.

Ridge Shingle: Using nail lines provided on top of vent, install the cap shingles directly to the vent, in

compliance with the shingle manufacturer's Notice of Acceptance (NOA) and

installation instructions, using roofing nails of sufficient length to penetrate through the sheathing a minimum of  $^{3}/_{16}$ " or at least 1" into wood plank decking thicker than 1".

**Ventilation Calculations:** Refer to manufacturer's published literature.




