RENEWAL of this NOA shall be considered after a renewal application has been filed and there has been no change in the applicable building code negatively affecting the performance of this product.







APPLICATION NOTES

1) SENERGY BASE COAT IS MIXED AT THE TIME OF USE PER SENERGY INSTRUCTIONS WITH PADDLE AND DRILL TO A HOMOGENEOUS CONSISTENCY.
2) A LAYER OF SENERGY BASE COAT IS APPLIED TO THE SHEATHING. HI-IMPACT 20 REINFORCING MESH IS EMBEDDED IN THE WET BASE COAT BY TROWELING FROM THE CENTER OUT. ALL EDGES ARE BUTTED.

3) APPLY SENERSHIELD-R TO DRY REINFORCED BASE COAT SURFACE UNIFORMLY AT 10 MILS WET.

4) APPLY SENERGY DRAINAGE MAT OVER SENERSHIELD-R WITH EDGES BUTTED. ATTACH TO SHEATHING WITH SUFFICIENT STAPLES TO STAY IN PLACE UNTIL INSULATION BOARD APPLICATION.

5) NEOPOR RIGID INSULATION BOARD HAS A NOMINAL DENSITY OF 1.35 PCF (ASTM C578 TYPE II) AND SHALL BE APPLIED HORIZONTALLY IN A RUNNING BOND PATTERN STAGGERING VERTICAL JOINTS AND CORNERS. 2 FASTENERS PER BOARD ARE USED TO HOLD IT IN PLACE UNTIL LATH INSTALLATION.

6) PERMALATH 1000 IS ATTACHED INTO THE FRAMING AT 6" OC WITH #8 X 2 5/8" SELF DRILLING SCREWS WITH WIND LOCK LATH PLATES (1 1/4" DIAMETER).

7) SENERGY STUCCOBASE IS MIXED AT THE TIME OF USE PER SENERGY INSTRUCTIONS

8) SENERGY STUCCOBASE IS APPLIED AT MINIMUM 1/2" THICKNESS. A DARBY IS USED TO LEVEL THE STUCCOBASE TO A CONSISTENT THICKNESS

9) SENERGY FINISH IS AN ACRYLIC BASED TEXTURED EXTERIOR COATING READY MIXED FROM THE FACTORY. IT IS APPLIED WITH A STAINLESS STEEL TROWEL AND FLOATED TO A DESIRED TEXTURE.

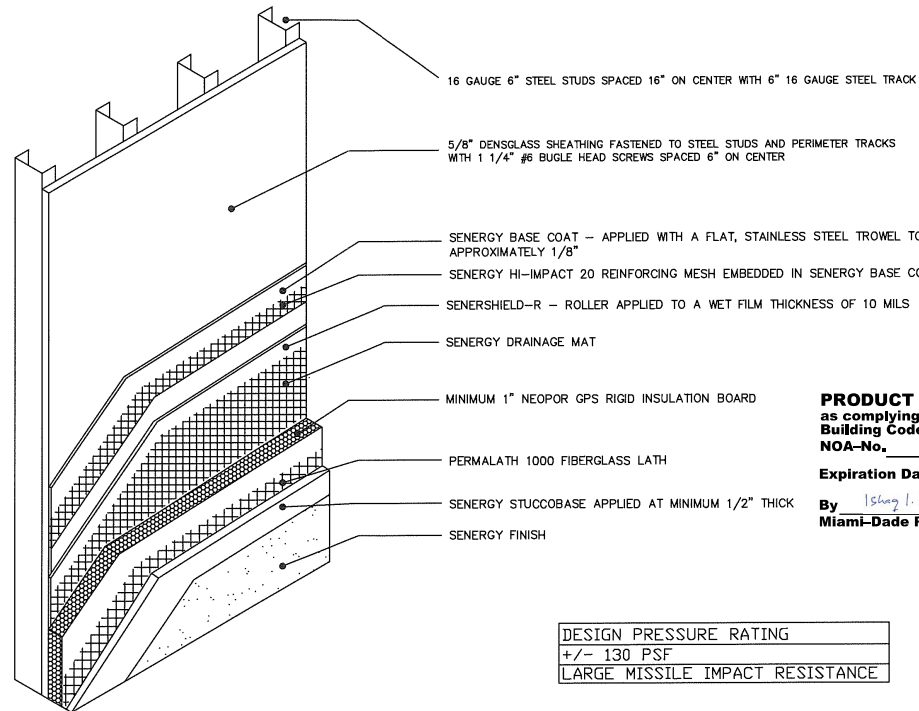

4) THE ENGINEER AND/OR ARCHITECT OF RECORD FOR EACH PROJECT USING THIS SYSTEM SHALL SIZE ALL STUD FRAMING TO ENSURE CONFORMANCE WITH STUD DEFLECTION AND STRESS LIMITATIONS AS REQUIRED BY GOVERNING CODE AND THIS DOCUMENT.

5) ALL STUDS USED WITH THIS SYSTEM SHALL BE COMPLETELY SHEATHED AT THE INTERIOR FLANGE OR BRIDGED AT MAXIMUM EVERY 5 FT. OF STUD LENGTH OR AS SPECIFIED BY THE STUD MANUFACTURER.

6) ALL STEEL STUDS SHALL BE STRUCTURAL WITH 1 5/8" MIN FLANGE WIDTH AND HAVE A MINIMUM YIELD STRENGTH OF 33000 PSI

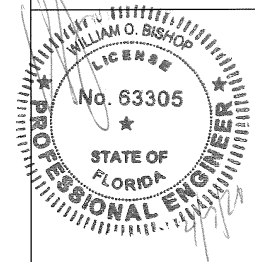
