

- 1) FINESTONE BASE COAT IS MIXED AT THE TIME OF USE PER FINESTONE INSTRUCTIONS WITH PADDLE AND DRILL TO A HOMOGENEOUS CONSISTENCY.
- 2) A LAYER OF FINESTONE BASE COAT IS APPLIED TO THE SHEATHING. FINESTONE HI—IMPACT 20 REINFORCING MESH IS EMBEDDED IN THE WET BASE COAT BY TROWELING FROM THE CENTER OUT. ALL EDGES ARE BUTTED.
- 3) APPLY FINESTOP RA TO DRY REINFORCED BASE COAT SURFACE UNIFORMLY AT 10 MILS WET.
- 4) APPLY FINESTONE DRAINAGE MAT OVER FINESTOP RA WITH EDGES BUTTED. ATTACH TO SHEATHING WITH SUFFICIENT STAPLES TO STAY IN PLACE UNTIL INSULATION BOARD APPLICATION.
