PVC



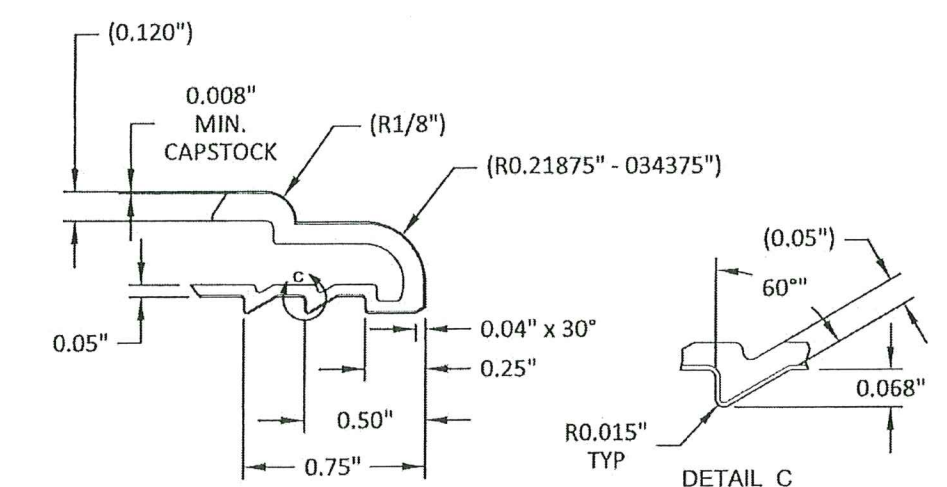
DETAIL OF NOTCHES
