


System Type: Mechanical attachment of ridge vent system over composition shingles.

Cutout:




Determine whether the rafters are truss or ridgepole construction. Cut sheathing 2" (truss) or 3-1/2" (ridge pole) wide slot (1" truss or 1-3/4" ridge pole on each side) of the ridge(s). A minimum of 6" must be left uncut on each end of the ridge. Once the slot is cut and any overlapping shingles covering the ridge are trimmed and removed, the ridge is ready for vent installation.

Installation:



- Place the vent routed side down along entire length of slot also covering the 6" minimum uncut ridge on both ends. Multiple lengths of vent can be joined by butting them together.
- Place the vent routed side down along entire length of slot also covering the 6" minimum uncut ridge on both ends. Multiple lengths of vent can be joined by butting them together.
- 4. Pull apart a pre-cut section of the foam end cap found with vent. Make a cut in the StormStopTM material ½" on each side, back from the end of section. Using an approved construction adhesive or sealant caulk, coat both sides of the StormStop material where it has been cut back at the end of the vent. Insert the foam end cap with the cut back StormStop material between the foam end cap and the underside of the vent to assure a weather-tight seal. Approved sealant must be applied to roof shingles before installing vent.




Using four (4) 2 ½ " long corrosion resistant ring shank roofing nails, attach vent to the roof deck by driving a nail in each of the two corners on both ends of the vent, and a nail at each side through the foam cap. Use 2 ½" long corrosion resistant ring shank roofing nails at 24" on center across the downslope of the ridge to attach vent. Apply an approved polyurethane adhesive sealant at the down-slope leading edges of the ridge vent, at the junction of the leading edge and asphalt shingles.

6. After vent has been installed, cut ridge shingles, preform, and install the cap shingles directly to the vent, in compliance with the shingle manufacturer's Notice of Acceptance (NOA) and installation instructions. Lap shingles with a 5" exposure over the ridge vent in a common overlapping pattern and attach using 2 ½" long corrosion resistant ring shank roofing nails through the ridge vent into the wood deck.

Net Free Area: Refer to manufacturer's published literature.

LIMITATIONS:

- 1. Refer to applicable Building Code for required ventilation.
- 2. Quarrix StormStop Ridge Vents shall comply with the manufacturer's current published application instructions and the requirements set forth in the applicable Building Code.
- 3. Quarrix StormStop Ridge Vents shall not be installed on roof mean heights greater than 33 feet.
- 4. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- 5. All approved products listed herein shall be labeled and shall bear the imprint or identifiable marking of the manufacturer's name or logo and following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below:




