#### APPROVED APPLICATIONS

Tradename: Tile Flat Top Off Ridge Vent

**System Type:** Mechanical attachment of static vent over "flat" profile concrete roof tile system.

**Cutout:** At chosen location (see L.V. Thompson's instructions for proper placement) and

centered between two roof rafters, cut a 46" long by 3" wide hole through sheathing

boards. Do not cut any rafters or structural members.


**Installation:** Flat profile concrete roof tiles shall be installed as per the manufacturer's

installation instructions.

Install the Tile Flat Top Off Ridge Vent with diverter/baffle, over the opening in the roof deck and fasten to the plywood sheathing as per manufacturer's installation instructions. **See Detail A Below**. The upper most edge of the vent is to be aligned with the top of the cut-slot and set in a bead of Miami Dade approved ASTM D4586 roof cement. After mechanically attachment as per Detail A (6in on center); seal all penetrations with Miami Dade Approved ASTM D 1668 fabric and Miami Dade approved ASTM D4586 roof cement. The Diverter/Baffle is to be fastened 2 ¾ in away from the vent opening and attached using two (2) #8-18x0.5in; Pan Head self-tapping screws on each side of the diverter/baffle.

**Net Free Area:** Refer to manufacturers published literature.





- 3. L.V. Thompson vents shall not be installed on roof mean heights greater than 33 feet.
- 4. All vents shall be permanently labeled with the manufacturer's name and/or logo, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.



5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
