System: TM Lock Panels

Deck Type: Wood, Non-Insulated

Deck Description: 15/32" or greater plywood or wood plank.

Slope Range: 2": 12" or greater

Maximum Uplift See Table A below

Pressure:

Deck Attachment: In accordance with applicable Building Code, but in no case shall it be less than 8d annular

ring shank nails spaced 6" o.c. In reroofing, where the deck is less than $^{19}/_{32}$ " thick (Minimum $^{15}/_{32}$ "). The above attachment method must be in addition to existing

attachment.

Underlayment: Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4"

side-laps and 6" end-lap fastened with corrosion resistant tin-caps and 11/4" annular ringshank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll;

Fire Barrier Board: Any approved fire barrier having a current NOA. Refer to a current fire directory listing for

fire ratings of this roofing system assembly as well as the location of the fire barrier within

the assembly. See Limitation # 1.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133

and with L.V. Thompson Inc.'s current published installation instructions.

Metal Panels and Accessories:

Install the TM Lock Panels and accessories in compliance with LV Thompson Inc.'s current, published installation instructions and details. Flashing, penetrations, valley construction and other details shall be constructed in compliance with the minimum requirements provided in

Roofing Application Standards RAS 133.

Panel fasteners shall be #10 x 1" galvanized, pancake head screw, Type 17 point of

sufficient length to penetrate through the sheathing a minimum of $^{3}/_{16}$ inch.

Fasteners shall be installed along the fastening strip at a maximum spacing as listed in **Table A**.

A continuous 3/16" bead of Bostik 70-05a adhesive shall be applied along the male rib

before snapping the panels together (see Detail A).

Fasteners shall be installed at a maximum of 6" o.c. at panel edge.

- **3.** Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.



5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.







TM-Lock










Rake Detail:









