Fire Barrier: Any approved fire barrier having a current NOA. Refer to a current fire directory listing for

fire ratings of this roofing system assembly as well as the location of the fire barrier within

the assembly. See Limitation #1.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133

and with the current published installation instructions and details in DMC Association of

Regional Manufacturers Installation Manual.

Metal Panels and Accessories:

Install the "Edge-Loc-1.5" Clipless x .032" (min.) Aluminum Panel" including flashing penetrations, valleys, end laps and accessories in compliance with PAC Contractors

Association's current, published installation instructions and in compliance with the

minimum requirements detailed in Roofing Application Standard RAS 133.

Panels shall be installed along the clipless seam with corrosion resistant #10 pancake head screws of sufficient length to penetrate through the sheathing a minimum of $^{3}/_{16}$ " at a distance listed below in **Table A**. A continuous bead of Bostik 70-05A adhesive shall be applied on each side of the male rib before snapping the female end of the adjacent panel in

place. See Details herein.


- 5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.






PROFILE DRAWING




