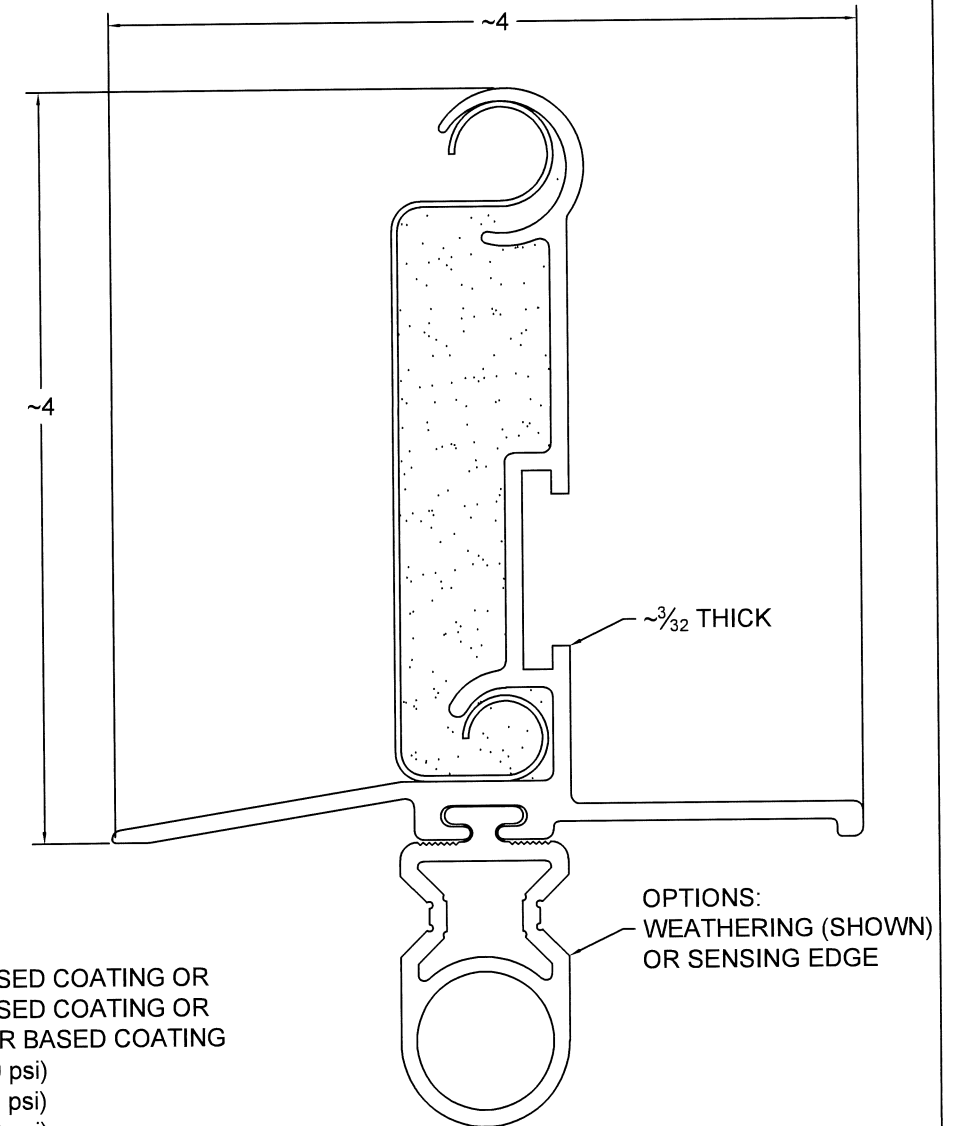
② GUIDE ASSEMBLY DETAIL
