th to p ir th b — 7 o — 8	This type of permit requires a "102-Buck and Fastener" inspection for windows requested online by the contractor when all windows are installed but do not caulk/seal/finish the interior frame perimeter to inspect shim space. This inspection is a final inspection which closes the permit. Standalone door ermits require a Final (001) Inspection when the door(s) are installed but do not caulk/seal/finish the interior frame perimeter to inspect shim space. Also, do not install any fastener cover plates within the frame that would conceal fasteners. A standalone garage door replacement permit requires a inal (001) Inspection when the overhead door is completely installed. Inspections will be performed by the County using a virtual or onsite inspection type at the discretion of the Building Official. Bedroom windows will continue to meet the requirements of emergency escape and rescue penings according to the Florida Building Code, Existing Building Volume Section 702.5. Florida Product Approvals and/or Miami-Dade County NOA's must be for the current building code. xpired "out of code cycle product" approvals or NOA's will not be acceptable. When the value of the window/door change out exceeds 30% of the assessed value of the building,
