EXECUTIVE SUMMARY

The Miami Dade County Business Development Mission to Sao Paulo and Belo Horizonte in Brazil (November 3rd- 6th, 2009) was unique in that it was the first time several chambers of commerce and economic development organizations from Miami-Dade County joined forces to plan and organize a business mission to Miami-Dade's top trading partner, Brazil.

Consistent with ITC's Strategic Plan, the Chair of the Western Hemisphere Trade Initiatives Ad-Hoc Committee (Committee) recommended to the ITC Board of Directors to undertake a mission to Brazil during Fiscal Year 08-09. The ITC Board of Directors unanimously approved the recommendations of the Committee Chair at its March 11th, 2009 meeting. Following approval by the Board, ITC met with the Brazilian Consulate in Miami to discuss issues related to logistics, as well as, the agenda for the mission. ITC staff carried out a premission trip to Sao Paulo and Belo Horizonte in May 2009. Upon return, ITC released the Save the Date and the registration package with the deadline of July 31st, 2009.

The Business Development Mission to Brazil (Sao Paulo and Belo Horizonte) took place from September 19th – 26th, 2009. A total of 17 persons registered but only 15 participated in the mission. Four delegates were from the government and the rest from the private sector, including a representative from the Coral Gables Chamber of Commerce and two representatives from The Beacon Council. ITC Chair, Commissioner Natacha Seijas led the Miami-Dade County Delegation. ITC Executive Director, Tony Ojeda and ITC Trade Development Specialist, Maria Dreyfus-Ulvert were responsible for coordination, implementation, and logistics.

EXECUTIVE SUMMARY (continued)

The purpose of the mission was to:

- 1. Consolidate and further strengthen trade ties between Miami-Dade County and Brazil.
- 2. Promote Miami-Dade's infrastructure as a global platform for international trade.
- Strengthen cultural ties between Miami-Dade County and the cities of Sao Paulo and Belo Horizonte.

During the mission, participants received in-country briefings from the U.S. Embassy and the U.S. Commercial Service and attended Miami-Dade County's branding presentations which provided an opportunity to liaise with key local and state government representatives. At the branding presentation, Chair Seijas provided an overview of County government. ITC Executive Director Tony Ojeda highlighted the County's role as a global platform for trade, given its superior infrastructure through the Port of Miami (POM) and Miami International Airport (MIA). The Beacon Council President and CEO, Frank R. Nero highlighted the many investment opportunities available in Miami-Dade and met with Brazilian companies interested in joint-ventures or investments.

Private sector participants had the opportunity to meet and network with their counterparts in Sao Paulo and Belo Horizonte. They also participated in pre-arranged business-to-business meetings with Brazilian companies organized by the Federation of Industries of the State of Sao Paulo (FIESP) and the Federation of Industries of the State of Minas Gerais (FIEMG), as well as, in informal business meetings organized by AMCHAM-Sao Paulo.

As a result of the mission:

- Private sector representatives had a total of 118 business-to-business matchmaking meetings. Forty-five business meetings were held in Sao Paulo and seventy three in Belo Horizonte. These meetings gave private sector delegates an opportunity to meet and establish business contacts with Brazilian counterparts.
- Miami-Dade County and economic development organizations had an opportunity to re-establish contacts with key public and private sector organizations in Sao Paulo and Belo Horizonte.
- Government and private sector organizations in Sao Paulo and Belo Horizonte received invitations for a reciprocal trade mission to Miami-Dade County.
- The Sister Cities relationship between Miami-Dade County and Sao Paulo was further strengthened.
- An incoming delegation from the State of Minas Gerais, led by its Secretary of Development visited Miami-Dade November 3rd - 6th, 2009

BACKGROUND

In 2006, the ITC Board of Directors created four regional Ad-Hoc committees to develop and expand trade and cultural linkages with other countries, thereby strengthening Miami-Dade County's role as a Global Gateway. The Jay Malina International Trade Consortium's (ITC) method for the selection of countries to be targeted for an ITC mission consists of a process that involves both staff research, feedback from stakeholders, and consultation and approval by the ITC Board of Directors.

Consistent with ITC's mission and Strategic Plan, the Western Hemisphere Trade Initiatives Ad-Hoc Committee (Committee) recommended countries in Latin America and the Caribbean to be visited during FY08-09. The Committee met on October 20th, 2008 under the Chairmanship of David Peña, and recommended ITC to lead a mission to Mexico, Guatemala, and Brazil in Fiscal Year 2008-2009. Mr. Peña's tenure expired, and ITC Chair, Commissioner Natacha Seijas appointed Ralph Gazitua as the new Committee Chair on January 14, 2009.

The Committee met twice on February 4th and February 23rd. Based on the overwhelming feedback received from over 15 stakeholders, Mr. Gazitua recommended at the March 11, 2009 ITC Board of Directors meeting that ITC lead a trade mission to Sao Paulo, Belo Horizonte, and Fortaleza, Brazil in the latter part of September 2009. The ITC Board, unanimously approved the recommendation of the Committee Chair.

At the ITC Board meeting of May 13th, 2009, ITC Executive Director Tony Ojeda reported that the U.S. Commercial Service in Sao Paulo suggested that given current economic conditions and limited resources that ITC's mission to Brazil be limited to Sao Paulo and Belo Horizonte. The ITC Board unanimously approved his recommendations.

The Beacon Council, the Brazilian-American Chamber of Commerce of Florida, the Coral Gables Chamber of Commerce, and the Latin American Chamber of Commerce (CAMACOL) supported the mission.

BACKGROUND (continued)

In June 2009 these organizations established the following objectives for the mission:

- To consolidate and further strengthen trade ties between Miami-Dade County and Brazil.
- 2. To promote Miami-Dade's infrastructure as a global platform for international trade.
- 3. To strengthen cultural ties between Miami-Dade County and the cities of Sao Paulo and Belo Horizonte.

TRADE OPPORTUNITIES:

Brazil is Miami-Dade's most important trading partner. It is the 10th largest economy in the world with a GDP of \$1.665 trillion, and has the largest economy in Latin America. In 2008, bilateral trade between the U.S. and Brazil totaled \$63.4 billion with a positive trade surplus for the U.S. Brazil is Miami Dade's largest trading partner, and South Florida is the main entry port for Brazilian goods entering the United States. In 2008, total trade between Brazil and the Miami Custom's District totaled \$13.7 billion, an increase of almost 23% from the previous year. In 2005, Brazil's Trade and Investment Promotion Agency (APEX-Brazil) opened the first distribution center of Brazilian products in the Miami Free Trade Zone. Miami was chosen for its prime location and excellent transport and logistics infrastructure.

The potential to further strengthen trade with Brazil is very strong given the increasing presence of Brazilians in Miami-Dade County. According to the Brazilian Consulate in Miami around 300,000 Brazilians reside in Miami-Dade. Furthermore, the Greater Miami Convention and Visitor's Bureau (GMCVB) estimated that approximately 460,000 Brazilians visited Miami in 2008.

PRE-MISSION ACTIVITIES

ITC and The Beacon Council staff met with the Brazilian Consulate in Miami to discuss upcoming Business Development Mission. The Brazilian Deputy Consul General, Luis Abbott-Galvao attended the ITC Board meeting on July the 8th to brief the Board on the support the Consulate was providing the mission by promoting, recruiting, and arranging meetings with Brazilian government and private sector organizations. Ambassador Luiz De Araujo Castro. Consul General of Brazil in Miami offered the support of his government during a meeting with Commissioner Seijas on September 2^{nd.}

ITC Trade Specialist Maria Dreyfus-Ulvert conducted an advanced site inspection visit to Sao Paulo and Belo Horizonte from May 16th - 23rd, 2009. The main objectives of the pre-mission trip were to work on the logistics, identify the mission costs, and establish government and with private organizations to develop an agenda for the mission. ITC sent a Save-the-Date for the mission in May 2009. On June 2009, ITC and the supporting organizations released an invitation for prospective participants to join the Business Development Mission to Brazil with a registration deadline of July 31st, 2009. ITC established the cost per mission participant for eight days at \$2,400 including airfare, lodging. transportation to official meetings. networking luncheons and receptions, and the mission registration fee.

Seventeen persons registered for the mission but only fifteen participated. There were four government delegates, two representatives of economic development agencies, and nine delegates from the private sector including: pharmaceutical and medical equipment, commercial and industrial lightning and fixtures, legal services, logistics, mining equipment, and environmental services. MEETINGS WITH BRAZILIAN OFFICIALS & SITE INSPECTION

PRE-MISSION BRIEFING

On September 1st, ITC convened a pre-mission briefing for all mission participants at the Stephen P. Clark Center. ITC Executive Director Tony Ojeda welcomed participants and reviewed the mission objectives and logistics. Mr. Ojeda thanked the supporting organizations, particularly the Brazil-American Chamber of Commerce of Florida, for their support during ITC's pre-mission trip to Brazil.

Deputy Consul General Luiz Abbott-Galvao indicated the importance of this mission to his country and brought special greetings from the Consul General. He also offered suggestions on how to best conduct business in Brazil. Mary Arnaud, Executive Director, Brazilian-American

BRANDING PRESENTATIONS IN SAO PAULO AND BELO HORIZONTE, BRAZIL

During the mission to Brazil, there were two branding presentations, one in Sao Paulo on September 21 at the Hilton Morumbi Hotel, and the other in Belo Horizonte on September 24 at the Federation of Industries of the State of Minas Gerais (FIEMG). These branding presentations had two purposes: 1) to highlight Miami-Dade County's infrastructure as a global platform for international trade; and 2) to strengthen trade and cultural ties between Miami-Dade County and the cities of Sao Paulo and Belo Horizonte.

ITC Chair, Commissioner Natacha Seijas reviewed the purpose of the mission and provided an overview of Miami-Dade County. She brought greetings from Miami-Dade County's Mayor Carlos Alvarez, the Board of County Commissioners, and the ITC Board.

ITC Executive Director, Tony Ojeda reviewed Miami-Dade County's transportation infrastructure, multilingual workforce, and its geographic location as a transshipment point for products destined to the U.S., Latin America, and the Caribbean. He also explained the role that the ITC, the Port of Miami, and Miami International Airport play in promoting Miami as a Global Gateway. Mr. Ojeda analyzed the trade figures between Miami-Dade and Brazil and highlighted ITC's programs for incoming missions, including business to business matchmaking services.

Frank Nero, President and CEO of The Beacon Council discussed the opportunities Miami-Dade offered as a business center of the Americas. He highlighted the top reasons for doing business in Miami-Dade County. He also mentioned the industries targeted for investment, the incentives available, and the role and assistance provided by The Beacon Council to potential investors.

In Sao Paulo, businesses and representatives of the following organizations attended the branding presentation: the U.S. Consulate and U.S. Commercial Service in Sao Paulo, the Government of the State of Sao Paulo, the City of Sao Paulo, the Federation of Industries of the State of Sao Paulo (FIESP), the Sao Paulo Committee of the Brazilian-American Chamber of Commerce of Florida, the Brazilian Export Promotion and Investment Agency (APEX), the Greater Miami Convention and Visitor's Bureau (GMCVB), and local businesses.

In Belo Horizonte, businesses and representatives of the following organizations attended the Miami-Dade presentation: the U.S. Commercial Service in Belo Horizonte, the Federation of Industries of the State of Minas Gerais, the Secretariat of International Relations of the City of Belo Horizonte, the Secretariat of Planning of the City of Belo Horizonte, the Secretariat of Economic Development of the State of Minas Gerais, the Industry Development Institute of Minas Gerais (INDI), the World Trade Center of Belo Horizonte, the Office of the Mayor of Belo Horizonte, and the U.S. Consulate in Sao Paulo.

MEETINGS WITH U. S. GOVERNMENT AGENCIES

Briefing by the U.S. Consulate and the U.S. Commercial Service in Sao Paulo

The U.S. Consul General in Sao Paulo, the Honorable Thomas J. White, addressed the delegation on September 21st at the Hilton Morumbi Hotel. He indicated Brazil was experiencing a period of stability, and that a 4% to 5% economic growth was expected for 2010. He shared his views that U.S. – Brazil relations were at its peak and commented that for every \$4 dollars of the Brazil/U.S. trade, \$1 dollar went thru Miami-Dade. Consul White commended the delegation for having selected Brazil and the cities of Sao Paulo and Belo Horizonte.

Following the Consul General's remarks, William Popp, the Deputy Consul General

provided an overview of the political and economic environment for doing business in Brazil. Sean Kelley of the U.S. Commercial Service reviewed the Brazilian economy, including challenges and opportunities of the Brazilian market. He highlighted the leading sectors for U.S. business and investment and noted the increased number of incoming missions from the U.S. As the top U.S. Commercial Officer responsible for the State of Minas Gerais, he also shared his views on the State of Minas Gerais.

MEETINGS WITH GOVERNMENT AGENCIES IN SAO PAULO AND BELO HORIZONTE SAO PAULO:

Secretariat of Development of the State of Sao Paulo:

On September 22nd, Miami-Dade County's official delegation visited the Honorable Geraldo Alckmin, Secretary of Development for the State of Sao Paulo.

Mr. Alckmin highlighted the economic activity and key economic sectors of the State and indicated the state's economy represented 33% of Brazil's total Gross Domestic Product (GDP). Mario Mugnaini, President of the Investment and Competitiveness Promotion Agency (INVESTE) presented the key on-going investment projects in the state, including the planned expansion of the Port of

Santos, the largest in Latin America. He also noted that many joint-venture opportunities would emerge as a result of the recent oil discovery off the coast of the state.

Commissioner Seijas extended an invitation to bring a reciprocal trade mission. During the meeting Frank Nero reviewed the role of The Beacon Council and the assistance his organization provides to companies wishing to relocate or expand operations in the Miami area. Tony Ojeda reviewed the County's role as a Global Gateway and offered ITC's assistance for an incoming trade mission from Sao Paulo.

SAO PAULO:

Municipality of City of Sao Paulo

On September 22nd, Alfredo Cotait-Neto, Secretary of International Relations at the City of Sao Paulo received the delegation on behalf of Mayor Gilberto Kassab. Also present at this meeting was his Chief of Staff, Guilherme F. Mattar and officials from the Sao Paulo City Hall.

At this meeting, Commissioner Seijas and Mr. Cotait-Neto discussed ways in which the two communities could strengthen their Sister Cities affiliation which was signed in 1988, and reviewed possible future cultural exchanges and other opportunities for increasing bilateral relations. The ITC Chair extended an invitation for Mr. Cotait-Neto to bring a delegation to Miami-Dade County and offered ITC's assistance.

ITC Executive Director, Tony Ojeda noted that Brazil was Miami-Dade's top trading partner with a total trade of \$13 billion, and that Miami-Dade was Brazil's main U.S. entry port for all Brazilian goods. Mr. Ojeda explained that ITC administered the Miami-Dade Sister Cities Program and reassured the Secretary of the County's commitment to work closely with the City of Sao Paulo in the future.

BELO HORIZONTE:

Speaker of the House of Representatives of the State of Minas Gerais

The Honorable Alberto Pinto Coelho, Speaker of the House of Representatives of the State Assembly of Minas Gerais received the Miami-Dade official delegation on September 24th, 2009 on behalf of Governor Aecio Neves in the Speaker's Reception Hall. Present at this meeting were Luiz Antonio Athayde, Under Secretary of the Secretariat of Economic Development of the State of Minas Gerais, and Danilo Colares.

During the meeting Speaker Pinto Coelho and Commissioner Seijas discussed the many opportunities for increased bilateral trade and cultural exchanges between Miami-Dade and Minas Gerais, and reviewed ways in which the County could assist in securing a trade mission from that State. Frank Nero reviewed investment opportunities in Miami and offered the assistance of The Beacon Council. Speaker Pinto Coelho reaffirmed the importance that Miami had to the economic development of Minas Gerais and Belo Horizonte and reassured the group of his continued support.

BELO HORIZONTE:

Secretary of Development of the State of Minas Gerais

Sergio Barroso, Secretary of Development of the State of Minas Gerais received the delegation at FIEMG Trade Center on September 25th. During this meeting he discussed his plans to make his state the next logistic hub for Brazil. He expressed an interest in developing closer economic ties with Miami Dade County because of the County's role as an international trade destination center.

Luiz Antonio Athayde, Under Secretary of Development reviewed Belo Horizonte's plans for a high tech corridor along with the proposed expansion of the Tancredo Neves International Airport for increased passenger and trade capacity. These projects would represent a

multibillion dollar investment in the infrastructure of the region and would provide opportunities for expanding the economic base of the area. Plans for the airport expansion were underway in light of Brazil's role as host for the 2014 World Cup. At the time of the mission, the Olympic Committee had not yet selected Brazil as site for the 2016 Summer Olympic Games. Secretary Barroso expressed his interest in linking Tancredo Neves International Airport with Miami International Airport (MIA) in light of their plans for expansion and the already existing direct flights between Miami and Belo Horizonte.

Commissioner Seijas congratulated Secretary Barroso for his vision and that of his government in expanding economic opportunities for the citizens of Minas Gerais and indicated Miami-Dade County would be pleased to work with the government of Minas Gerais in cooperating with their efforts to expand their economic base. Frank Nero reviewed the many multinational corporations located in Miami with access to Latin American and Caribbean market that could benefit from the economic development in Minas. Commissioner Seijas extended an invitation for Mr. Barroso to visit Miami during the forthcoming Air/Sea Cargo Show, and Mr. Ojeda offered ITC's support in organizing agency coordination meetings during the visit to Miami.

SAO PAULO

Federation of Industries of the State of Sao Paulo (FIESP)

Roberto Giannetti, Director, Department of International Relations and Trade (DEREX) welcomed the delegation on September 22, 2009.

FIESP's Assistant Director. Antonio Bessa reviewed Sao Paulo's economy and discussed structure, FIESP's role, services as a key private sector organization representing corporate unions from 150,000 industries of different sizes and sectors. Mr. Bessa also indicated **FIESP** that employed

approximately 15,000 people, half of which were teachers or instructors from the FIESP system. The state of Sao Paulo represents 33% of Brazil's Gross Domestic Product (GDP) with a potential economic growth of 4% - 5% in 2010.

FIESP is in favor of the elimination of the U.S. tariff on Brazil's ethanol because Brazilian sugar is not grown in environmentally sensitive areas, and Brazilian sugar refineries can switch their sugar production to ethanol making this fuel very competitive for the U.S. consumer market. FIESP offered to organize a seminar on the advantages of Ethanol in Miami-Dade.

Commissioner Seijas recognized FIESP's assistance in the organization of business to business matchmaking sessions in Sao Paulo for private sector delegates. She extended an invitation for FIESP to bring a trade mission to Miami-Dade and offered ITC's assistance.

BUSINESS NETWORKING RECEPTIONS IN SAO PAULO

Delegates attended a business networking reception at the Intercontinental Hotel entitled: "Where World Meets", organized by the Greater Miami Convention and Visitors Bureau (GMCVB) on September 21. "Where Worlds Meet" is a global marketing campaign to promote Miami-Dade County as a dynamic world-class business, destination for meetings, vacations, and new business locations. The campaign is a collaborative effort of the GMCVB, The Beacon Council, American Airlines, the Miami Downtown Development Authority (MDDA), Miami-Dade County, Baptist Health Systems, Miami International Airport (MIA), and the Port of Miami (POM).

The business networking reception marked the first public relations event of Phase II of the Sao Paulo marketing campaign program. Eighty persons representing the travel industry, including travel trade, meeting planners, business site selectors, and journalists attended the event.

On September 22nd, Vertical Source Pharma hosted a business networking reception at the Hilton Sao Paulo Morumbi which provided delegates with the opportunity to meet and continue the dialogue with Brazilian entrepreneurs they had met earlier.

BELO HORIZONTE

Federation of Industries of the State of Minas Gerais (FIEMG)

Carlos Eduardo Abijaodi, Superintendent for Entrepreneurial Development at FIEMG received the delegation on September 24th. FIEMG is a one stop shop for businesses in Minas Gerais and through its International Business Center (CIN) supports local industries in their efforts to expand foreign trade. FIEMG also encourages international cooperation with other organizations to stimulate and expand their competitive insertion in the global market.

Commissioner Seijas expressed her appreciation to FIEMG for its generous support in organizing the business to

business matchmaking meetings. The ITC Chair extended an invitation to Mr. Abijaodi to bring a business delegation to Miami-Dade and offered ITC's assistance. ITC's Executive Director, Tony Ojeda explained that ITC could organize business meetings and arrange briefings with economic development agencies in Miami-Dade.

EXPOSIBRAM

A group of the Miami-Dade business delegates visited EXPOSIBRAM 2009, an International Mining Exhibition held at EXPOMINAS in Belo Horizonte on September 24th. Delegates had an opportunity to establish contact with different companies from the mining sector and to discuss the current trends in that industry. EXPOSIBRAM extended courtesy invitations to the Miami-Dade delegation to attend the exhibition.

BUSINESS TO BUSINESS MATCHMAKING MEETINGS IN SAO PAULO AND BELO HORIZONTE

The business matchmaking program is one of the highlights of ITC's mission and is provided to business mission participants at no charge. The business-to-business matchmaking sessions provided an opportunity for private sector participants to meet in an informal business setting with local businesses that had expressed an interest in meeting with them.

As part of the registration process, Miami-Dade businesses were asked to fill out and submit a company profile along with the registration form. The company profile was then sent ahead of time to the local economic development organizations that specialize in providing business matchmaking services and with whom ITC's had partnered to provide this service in each of the cities visited. FIESP, AMCHAM Sao Paulo, and FIEMG received the company profiles of the business delegation. The local partner organizations worked closely with ITC staff to match sector interests of mission participants with local businesses, thus increasing the opportunities for private sector delegates to establish business contacts. The schedule of business matchmaking meetings was distributed to mission participants ahead of time to allow them to prepare for these meetings and also to schedule individual business meetings with clients.

In Sao Paulo, FIESP assisted ITC with the matchmaking meetings on September 22nd at FIESP's headquarters. The 3 hour session for the Miami-Dade private sector delegates generated a total of **45 meetings** with their counterparts in Sao Paulo. In Belo Horizonte, the International Business Center (CIN) of FIEMG organized a total of **73 business matchmaking meetings** on September 25th at FIEMG's International Business Center. A total of **118 business-to-business matchmaking meetings** were held during the Business Development Mission to Sao Paulo and Belo Horizonte. Follow-up appointments with the Brazilian companies were made by some business delegates during their stay in each city. The business matchmaking sessions took place while the government delegation held simultaneous meetings with their counterparts.

"I would like to congratulate you (Maria) for a well organized, productive and enjoyable mission to São Paulo and Belo Horizonte last month. It was my first trade mission of this type, and I consider it to have been a success for my part. Since returning from the trip less than three weeks ago, I have performed legal services ... arising directly from the trip. I have a pending request for a fee quote and have sent 5 proposals to companies that I met during the trip.... More importantly, each of these proposals is for advice to companies that are considering entering the U.S. market in their respective sectors. All but one would likely enter through South Florida. These companies may either bring new jobs or help maintain current ones in the county. I have not completed my follow-up with all the companies that I met with. Therefore, there is potential still for further business to be generated. One of the most pleasant surprises of the trip was the degree and volume of exposure to credible companies that I received. I was very well received, and in both São Paulo and Belo Horizonte there was insufficient time to meet with all of the businesses who wanted to meet with me. As a result, I am currently planning a follow-up trip to São Paulo and Belo Horizonte to continue meeting new leads and follow up with the ones that I already have. Also, the fact that the mission was a public-private mission with public officials provided a degree of credibility, access and cooperation that I never would have achieved had I travelled on my own. I have real contacts with important organizations such as the FIESP, the American Chamber of Commerce and the FIEMG that I otherwise might not have. These organizations can help me in future returns to Brazil. There is no doubt in my mind that the ITC mission has not only benefitted my practice but will benefit Miami-Dade in terms of trade, goodwill and job creation."

Another mission participant who had not participated in previous ITC's missions indicated that his objectives for participating in this mission where met since his company was "looking for an Agent and we are working with three...during the mission we had about 15 very useful meetings...." He also reported that "...we are currently working with a customer that will visit us shortly after he returns from Brazil. We are receiving imports shipment from an agent we met in Sao Paulo, and we registered with the Brazilian Consulate two agents that wanted to represent our business in Brazil..."

CONCLUSIONS AND RECOMMENDATIONS

The Business Development Mission to Sao Paulo and Belo Horizonte, Brazil (September 19th- 26th) was unique in that it was the first time that several key chambers of commerce and economic development organizations from Miami-Dade County partnered with ITC to undertake a Business Development Mission to Miami-Dade's top trading partner. The mission visited two of the most important business cities in Brazil, Sao Paulo and Belo Horizonte.

The mission was successful in meeting its stated objectives of further strengthening the trade ties between Miami-Dade County and Brazil; promoting Miami-Dade's infrastructure as a global platform for international trade; and strengthening cultural ties between Miami-Dade County and the cities of Sao Paulo and Belo Horizonte.

As a result of this mission the following was achieved:

- Private sector participants had a total of 118 business-to-business matchmaking appointments with local Brazilian businesses that could result in future business relationships.
- ITC Chair, Commissioner Natacha Seijas extended a formal invitation to both government and private sector organizations in Sao Paulo and Belo Horizonte to bring trade missions to Miami-Dade in the near future.
- The Secretary of Economic Development for the State of Minas Gerais, the Honorable Sergio Barroso, accepted Commissioner Seijas' invitation to visit Miami-Dade from November 3rd 6th, 2009. The delegation from the State of Minas Gerais requested assistance from ITC in setting up the mission agenda. The delegation also attended the Air & Sea Cargo Americas Show.
- Mission participants received a thorough briefing by staff from the U.S. Embassy and its Commercial Service on the political and economic situation of Brazil. This information helped business delegates understand the challenges and identify the business opportunities available in Sao Paulo and Belo Horizonte.
- The mission to Sao Paulo helped revitalize the ties that existed between the City of Sao Paulo and Miami-Dade County which have had a Sister Cities affiliation since 1988. This effort may result in possible cultural exchange opportunities and technical cooperation between both cities.

CONCLUSIONS AND RECOMMENDATIONS (continued)

- Through Miami Dade's comprehensive branding presentations more foreign government officials and private sector organizations in the cities visited became acquainted with Miami-Dade's role as a platform for international trade and gateway to the U.S.
- Brazilians from the private and public sector became aware of the many investment and joint-venture opportunities available between Miami-Dade County and Brazil.
- Business delegates attended EXPOSIBRAM, the largest mining show in Brazil which has in past years attracted approximately 45,000 participants.

Finally, we cannot underscore enough that ITC's Business Development Mission to Brazil resulted in strengthening commercial and cultural ties between Miami-Dade and its most important trading partner.
