RESOLUTION CALLING SPECIAL ELECTION ON AUGUST 15, 1961, FOR THE PURPOSE OF SUBMITTING TO THE VOTERS OF DADE COUNTY PROPOSED AMENDMENT TO THE HOME RULE CHARTER REPEALING SECTIONS 9.03 (A) and 9.03 (B) RELATING TO THE REASSESSMENT OF ALL TAXABLE PROPERTY IN DADE COUNTY

WHEREAS, Section 9.03 of the Home Rule Charter requires the reassessment of all taxable real and tangible personal property in Dade County, and provides that such reassessment shall be completed by January 1, 1961, and that the 1961 County tax assessment rolls shall reflect such reassessment; and

WHEREAS, the reassessment of all taxable real property was completed by January 1, 1961, and the 1961 County tax assessment rolls are being prepared upon the basis of such reassessment; and

WHEREAS, the County Manager heretofore recommended that the time for utilization of such reassessment as the basis for County tax assessment should be extended in order that it be determined with certainty that the reassessment of all taxable property in Dade County has been accomplished with uniformity, equality and accuracy, or that the Charter provisions requiring complete reassessment by a specific date be repealed; and

WHEREAS, the County Commission finds and determines that the public interest and welfare require submission to the voters of a proposed Charter amendment repealing the provisions of the Charter requiring the reassessment of all taxable property in Dade County by January 1, 1961,

<u>Section 1</u>. The County Tax Assessor is hereby authorized and directed to make up the 1961 County tax assessment rolls upon substantially the same basis as the 1960 County tax assessment rolls, without regard to the reassessment valuations, subject to approval by the voters of Dade County at the special election herein called for the purpose of submitting a proposed Charter amendment.

Section 2. Pursuant to the provisions of Section 8.07 of the Home Rule Charter, a special election is hereby called in Dade County, Florida, on Tuesday, August 15, 1961, for the purpose of submitting to the voters of Dade County a proposed amendment to the Home Rule Charter repealing the mandatory provisions requiring the reassessment of all taxable property in Dade County by January 1, 1961. At such special election, there shall be submitted to and voted upon by the qualified electors of Dade County participating in such election, and determined by a majority of the electors voting at such election, the following question:

> "Shall the home rule charter of government for Dade County be amended, revised and modified by repealing Sections 9.03 (A) and 9.03 (B) relating to the reassessment of all real and tangible personal property in Dade County.

Section 3.
